## REPLACEMENT AND RELOCATION OF APPROVED THIRD-PARTY DIGITAL ADVERTISING SIGNAGE WESTERN DISTRIBUTOR, PYRMONT

Dear Ms Fishburn,

Reference is made to Department of Planning and Environment (Department) correspondence, regarding the abovementioned application which was referred to Transport for NSW (TfNSW) for comment as per clause 3.16 (6) of the *State Environmental Planning Policy (Industry and Employment) 2021* and concurrence under section 138 of the *Roads Act 1993*. TfNSW advises that:

- This response be read in co-junction with TfNSW response (CD23/02495) dated 21 June 2022 on matters pertaining to TfNSW concurrence under 2.99 of the State Environmental Planning Policy (Transport and Infrastructure) SEPP 2021.
- TfNSW is the relevant Roads Authority for the Western Distributor.

As such, TfNSW has reviewed the development application and would provide concurrence under section 138 of the Roads Act 1993 for the proposed works and structures over the Western Distributor, subject to the Department's Approval and the following conditions being included in any Consent issued:

- The proposed signs shall be in accordance with the Transport Corridor Outdoor Advertising and Signage Guidelines 2017.
- Dwell times between displays shall be no shorter than 10 seconds.
- The images displayed on the sign must not contain/use:
  - Flashing or flickering lights or content.
  - o Animated displays, moving parts or simulated movement.
  - o Complex displays that hold a driver's attention beyond "glance appreciation".
  - Displays resembling traffic control devices by use of colour, shape or words that can be construed as giving
    instruction to traffic for example, red, amber, or green circles, octagons, crosses, triangles, and words such as 'stop' or
    'halt'
  - o A method of illumination that distracts or dazzles; and
  - o Dominant use of colours red or green.
- A Road Occupancy Licence (ROL) should be obtained from Transport Management Centre for any works that may impact on traffic flows on the surrounding classified road network and signalised intersections during construction activities. A ROL can be obtained through https://myrta.com/oplinc2/pages/security/oplincLogin.jsf.
