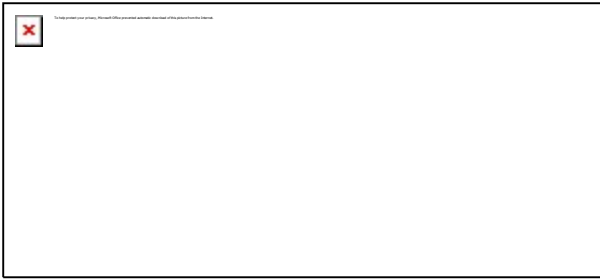

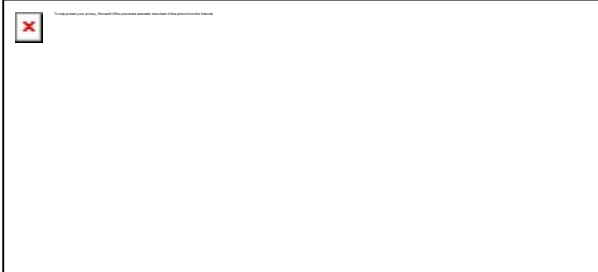
Hi Graham

The new consultant for the owner of site 2 has almost finalised a revised planning proposal in accordance with the gateway determination. The major delay has been finalising access arrangements with TfNSW – there has been a LOT of toing and froing with this issue I think in part because they want very detailed plans for the proposed new access to the highway.

The new owners of site 1 have recently confirmed they do not wish to proceed with the planning proposal. As soon as the owners of site 2 submit their revised planning proposal I will submit to you with a request to exhibit the amended planning proposal in accordance with the gateway determination and amend the gateway determination to remove Site 1 and seek an extension for 6 months.
