## Planning proposal PP-2020-2816 – Alteration of Gateway Determination

I refer to your email in relation seeking an extension of time to the public exhibition milestone to complete a Aboriginal Cultural Heritage Assessment (ACHA) in relation to PP-2020-2816 (former reference: PP\_2020\_CAMPB\_004\_00) for the proposed rezoning of E3 Environmental Management land to part R2 Low Density Residential; E2 Environmental Conservation; RE1 Public Recreation, and; SP2 Special Purposes - Drainage Zones at 71 St Andrews Road, Varroville.

I have determined as the delegate of the Minister, in accordance with section 3.34(7) of the *Environmental Planning and Assessment Act 1979*, to alter the Gateway determination dated 11 January 2021 for PP-2020-2816. The Alteration of Gateway determination is enclosed.

The amended milestone to require public exhibition to commence by 5 July 2021 provides additional time to complete an Aboriginal Cultural Heritage Assessment (ACHA), as required by the Gateway condition 1(d). The Department of Planning, Industry and Environment (the Department) consulted Heritage NSW regarding the updated milestones in the alteration and based on advice received, a draft ACHA (stage 4) is acceptable to form part of the exhibition material for the proposal. The Department will contact you for an update in mid-May, as we will need the draft AHCA the week commencing 14 June 2021 to ensure exhibition can commence in early July.

The overall timeframe to complete the proposal remains unchanged and the Panel's request for the Department to draft and finalise the LEP is required by 29 October 2021. If further time is required, a request to the Panel to withdraw and resubmit the proposal when the outstanding issues are resolved should be considered.
