I am writing to inform you that the Department of Planning and Environment has considered the advice issued by the Independent Planning Commission on 2 November 2018 for the Gateway determination review for O'Connell Road, O'Connell.

I have considered the reasons for the Gateway determination issued by the Minister's delegate on 30 May 2018, your submission outlining why the Gateway determination should be altered to delete condition 1 and the commission's advice. I have enclosed a copy of this advice for your reference.

The commission considers that the planning proposal is inconsistent with NSW planning policies, does not demonstrate strategic merit and that condition 1 of the Gateway determination should be retained in its entirety.
