MATTER DETERMINED

2019WES003 – Hay Shire Council – DA2019-040 at Lot 110 DP 1187931, Mid-Western Highway, Hay NSW 2711 – Construction of a 5MW solar farm using single axis trackers (as described in Schedule 1)

PANEL CONSIDERATION AND DECISION

The Panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and briefings and the matters observed at site inspections listed at item 8 in Schedule 1.

The Panel determined to approve the development application pursuant to section 4.16 of the *Environmental Planning and Assessment Act 1979*.

The decision was unanimous.

REASONS FOR THE DECISION

- The development is permissible with consent under the provisions of *State Environmental Planning Policy (Infrastructure) 2007.*
- The Panel is satisfied that the potential visual impact of the development on surrounding land uses and vehicles on the Mid Western Highway can be mitigated through appropriate screening of the development including a vegetative screen along the southern boundary.

CONDITIONS

The development application was approved subject to the conditions in the Council Assessment Report with the following amendments.

Include a new Condition requiring the Applicant to prepare an Emergency Management Plan:

Prior to the issue of any Construction Certificate an Emergency Management Plan (EMP) for the development shall be submitted to and approved by Council. The EMP shall address emergency management procedures associated with fire risk as a consequence of the built features of the development (i.e. solar panels, electrical wiring, substations etc), including containment of any contaminants on-site.

Amend Condition 23(a) to include the following words at the end:

in particular, the Applicant shall plant vegetative screening along the southern (Mid-Western Highway) boundary. Details of the screening shall be submitted for the approval of the Council in consultation with the Roads and Maritime Service.
