The subject property is located within the catchment areas of Section 7.11 Contributions Plan No. 19 – Blacktown Growth Precinct. Our records indicate that S7.11 contributions are payable on this land.

The following monetary contributions under Section 7.11 of the *Environmental Planning & Assessment Act 1979* must be paid prior to the issue of any Construction Certificate or Subdivision Certificate, whichever occurs first.

Hi Jared,

The environmental impacts of proposed seniors housing activity will be assessed through a Division 5.1 assessments referred to as a Review of Environmental Factors (REF) and an activity determination (approval) and identified requirements (similar to conditions of consent) will be issued. NSW Land and Housing Corporation will include an identified requirement (condition) in the activity determination requiring payment of the local infrastructure contribution for Stormwater Treatment based on quote provided by Blacktown City Council before commencement of construction. Once the activity determination is issued a 'Decision to Proceed letter' will be sent to the council and the Activity determination with identified requirements, REF that includes full response to Council's submission, approved plans and supporting documents will be available on the NSW Planning Portal.

In view of the above, we would like Blacktown Council to reconsider LAHC's proposal about payment of contribution in lieu of providing water quality systems, in accordance with the Part J of Blacktown DCP.

Thank you for your email.

The \$7.11 contributions are applicable to **development with consent**.

Subdivision 3 Local infrastructure contributions

7.11 Contribution towards provision or improvement of amenities or services (cf previous s 94)

- (1) If a consent authority is satisfied that development for which **development consent** is sought will or is likely to require the provision of or increase the demand for public amenities and public services within the area, the consent authority may grant the development consent subject to a condition requiring—
- (a) the dedication of land free of cost, or
 - (b) the payment of a monetary contribution,
- or both.

NSW Land and Housing Corporation (a social housing provider as per definition in Housing SEPP 2021) is carrying out seniors housing on the site as '**Development without consent**' under Division 8, Part 5, Chapter 3 of the Housing SEPP 2021. Therefore, the development contributions are not applicable.

I would like to note that NSW Land and Housing Corporation intends to pay the contributions voluntarily in lieu of providing water filtration system . Please see my latest email to Jared as attached.

The council requires to provide WSUD chamber and a MUSIC model to ensure the water quality target has been achieved. The subject land is within Blacktown Growth Centre where Section 7.11 Contributions Plan apply. As per the part J – Water Sensitive Urban Design and Integrated Water Cycle Management within Blacktown DCP 2015, the water quality requirements can be met through the provision of contributions in accordance with this contribution plan. We would appreciate your advice if Blacktown Council would accept the contribution in lieu of providing the water quality filtration chamber and MUSIC model.
