Demolition of 3 existing dwellings and structures, removal of trees, and the construction of a 12 dwelling **seniors housing development** comprising 6 x 1 bedroom and 6 x 2 bedroom self-contained dwellings, with associated landscaping and fencing, surface parking for 6 cars, and consolidation of 3 lots into a single lot.
