ST GEORGE HOSPITAL - REFURBISHMENT

Overall Description of Works:

- 1. Internal refurbishment works within existing hospital buildings.
 - a. Burt Nielson Wing Level 1 Fluoroscopy
 - b. Burt Nielson Wing Level 2 Paediatrics and CYF
 - c. Clinical Services Building & Services Block Ground Floor Back of House
 - d. Ward Block Level 2 Multi-faith, Patient Transit and AAU
 - e. Tower Ward Block Level 4 Renal
 - f. Tower Ward Block Level 6 Surgical
 - g. Prichard Wing Various Levels Sexual Health, Antenatal and Gynaecology
 - h. Acute Services Building Level 7 Palliative Care
- 2. Minor extension for a new Clinical Waste building within the hospital campus and new covered walkways
- 3. Services upgrade/modification works & new services installations including but not limited to lighting, hydraulics, mechanical, fire and stormwater and drainage
- 4. Demolition of existing buildings within the hospital campus and wider precinct
- 5. Civil & Landscaping works adjacent to Belgrave Street for continuation of the Ambulatory Care main entry forecourt area

Specific Electrical Services Works:

Fire Detection and Emergency Warning and Intercom Systems within the refurbishment areas only.
