This message came from outside your organization.

Dear Abbey,

Council has reviewed the submitted documentation, despite still awaiting Council's internal branches referrals, the following items are noted by review of Council's Development Planning Branch.

- The proposed driveway crossing should be relocated to be at least 1m from the property boundary.
 This is to allow for 1m of dense perimeter landscaping along all sections of vehicular circulation space.
- The proposed overhang of the first floor over the at-grade carpark, i.e. units 9 and 10, would likely
 be inconsistent with the surrounding built character of the area, and should be removed from the
 proposed development.
- It should be noted that the subject site is immediately adjacent the intersection of Birdwood and Moonshine Avenues. Due to the slope of the land, the development should be mindful of designing the building to reduce instances of headlight spill into the units, by vehicles travelling south along Moonshine Avenue.
