Is the proposal compatible with the existing or desired future character of the area or locality in which it is proposed to be located?	The signage proposed is of a scale and design which is compatible with the future character of development in the area as a business development zone.	✓
Is the proposal consistent with a particular theme for outdoor advertising in the area or locality?	The proposed signage is consistent with signage in the surrounding area. The proposal does not include third party advertising.	✓
<b>2 Special areas</b>		
Does the proposal detract from the amenity or visual quality of any environmentally sensitive areas, heritage areas, natural or other conservation areas, open space areas, waterways, rural landscapes or residential areas?	The proposal does not detract from the visual quality of the surrounding waterway, signage has been designed to include high quality materials and placed to contribute to the aesthetic of the area.	✓
<b>3 Views and vistas</b>		
Does the proposal obscure or compromise important views?	The signage proposed as part of the high school does not obscure any important views.	✓
Does the proposal dominate the skyline and reduce the quality of vistas?	The proposed signage is modest in scale, it will not dominate the skyline or reduce the quality of vistas.	✓
