NSW Health Infrastructure (HI) is proposing the partial refurbishment of the existing Finley Health Service at 24 Dawe Avenue Finley 2713. The legal description for the site is Lot 246 DP 1016411, in the Berrigan Shire Local Government Area (LGA).

The NSW Government has committed \$25 million to the Finley Health Service redevelopment as part of the \$500 million rural health boost. The project involves a minor extension to the existing hospital building to deliver 6 new inpatient beds, internal refurbishment of emergency department and medical imaging, services upgrade, new main entrance, landscaping and a new roof. This will enhance the current service and facilities, ensuring healthcare services meet the needs of the community, including outlying areas, now and into the future.


