1 EXECUTIVE SUMMARY

A Flora and Fauna Assessment has been conducted to identify potential constraints that may impede the future school infrastructure of the Melrose Park High School. This assessment aims to seek approval for a development without consent application under Part 5 of the EP&A Act, mitigating any risks during the delivery of the school. This report documents the findings of the biodiversity assessment, identifying potential biodiversity constraints relevant to the proposed development under the NSW Biodiversity Conservation Act 2016, Commonwealth Environment Protection and Biodiversity Conservation Act 1999, and the NSW Fisheries Management Act 1994.

As the planning pathway is under Part 5 of the EP&A Act a Biodiversity Development Assessment Report (BDAR) nor Species Impact Statement (SIS) was required for the proposed development of Melrose Park High School.

Melrose Park High School is a cleared site. No significant biodiversity areas were mapped, and no Plant Community Types were found on site. All mapped threatened species were determined to have a low likelihood of occurrence, and no evidence of threatened species was observed during the site assessment. The site had no Key Fish habitat.

The Flora and Fauna Assessment concluded that there will be no significant impacts on matters of national environmental significance. As there were no threatened species found, a Test of Significance was not required. Consequently, no referral to the Australian Minister for the Environment under the Environment Protection and Biodiversity Conservation Act 1999 is required. The proposal would be unlikely to cause a significant impact on the environment. Therefore, it is not necessary for an Environmental Impact Statement to be prepared and approval to be sought from the Minister for Planning under the Environment Protection and Biodiversity Conservation Act 1999.

2 INTRODUCTION AND DECLARATION

This Melrose Park High School Flora and Fauna Assessment (FFA) has been prepared by Water Technology on behalf of the Department of Education (DoE) to assess the potential environmental impacts that could arise from the construction and use of the new Melrose Park High School project (the Activity) at 37 Hope Street, Melrose Park. This report supports the assessment of the proposed Activity under Part 5 of the Environmental Planning and Assessment Act 1979. The Activity is proposed by the DoE to meet the growth in educational demand in the Melrose Park precinct.

This report has been prepared to assess potential biodiversity impacts for the Melrose Park High School.

This report accompanies a Review of Environment Factors (REF) that seeks approval for redeveloping the Melrose Park High School. Refer to the Review of Environmental Factors for a full description of works.

The Melrose Park High School will be assessed under Part 5, Division 5.1, the Department of Education serves as both the proponent and the determining authority. The Department of Education must examine all matters likely to affect the environment from this activity.

The construction company will make sure the proposal is carried out as described in this FFA. If the scope of work or work methods, described in this FFA, change significantly following determination, an additional environmental impact assessment, or FFA Addendum, may be required.

2.1 Summary of the Activity

The proposed activity involves the construction and use of a new high school in two stages for approximately 1,000 students.

Stage 1 of the proposed activity includes the following:

- Site preparation works.
- Construction of Block A a six-storey (with additional roof/plant level) school building in the south-western
 portion of the site containing staff rooms and General Learning Spaces (GLS).
- Construction of Block B a one storey (double height) hall, gymnasium, canteen and covered outdoor learning area (COLA) building in the south-eastern portion of the site.
- Construction of Block C a single storey plant and storage building at the north-eastern portion of the site.
- Associated landscaping.
- Construction of on-site car parking.
- Provision and augmentation of services infrastructure.
- Associated public domain infrastructure works to support the school, including (but not limited to):
- Provision of kiss and drop facilities along Wharf Road, and widening of the Wharf Road footpath.
- Raised pedestrian crossings on Wharf Road and Hope Street.

Stage 2 of the proposed activity includes the following:

- Construction of Block D a five-storey (with additional roof/plant level) school building in the north-western portion of the site containing staff rooms and GLS:
- Additional open play spaces within the terrace areas of Building D.
- Minor layout amendments to Block A.

The Review of Environmental Factors prepared by Ethos Urban provides a full description of the proposed works.

2.2 Determination

- The proposed activity can proceed subject to mitigation measures and/or conditions relayed in this FFA.
- The activity is unlikely to be classed as a controlled action under the Commonwealth Environmental Protection and Biodiversity Conservation Act 1999 (EPBC Act) so no referral is required.

2.3 Significance of Environmental Impacts

Based on the identification of potential issues, and an assessment of the nature and extent of the impacts of the proposed development, it is determined that:

- The extent and nature of potential impacts are low and will not have significant impact on the locality, community and/or the environment.
- Potential impacts can be appropriately mitigated or managed to ensure that there is no significant impact on the environment.

4 PROJECT JUSTIFICATION

The Melrose Park High School is part of the NSW Government's plan to rebuild public education in 2024-25. This will ensure growing communities get access to public education.

4.1 Options

Option 1 – Do Nothing: Demand for high schools in the region will remain unmet.

Option 2 – Implement Project Proposal: (Preferred option) Melrose Park High School enhanced by providing more educational facilities for the local community. By providing enhanced services and spaces, the new proposed Melrose Park High School aims to meet the current and future needs of the community.

4.2 Consideration of Ecologically Sustainable Development

The proposal has been considered against the principles of ecologically sustainable development (ESD) (refer to Table 4-1).

5 SITE DESCRIPTION

5.1 Site Location and Background

The site is located at 37 Hope Street, Melrose Park within the Parramatta LGA. The school covers an approximate area of 9,500m² and is generally rectangular in shape. The site is currently cleared and vacant. The site is located approximately 8km east of the Parramatta CBD.

Melrose Park High School is a cleared lot with no buildings and no trees. An aerial image of the site is shown in Figure 5-1 below. The property boundary is distinct from the surveyed site.

6 RELEVANT LEGISLATION

Legislation and policy relevant to the biodiversity component of works within the subject site are outlined below:

6.1 Environmental Planning, Assessment Act 1979 and Local Government Act 1993

Planning and development within NSW is regulated by the Environmental Planning & Assessment Act 1979 (EP&A Act).

The proposed works are permitted without consent under the State Environmental Planning Policy (Transport and Infrastructure) 2021 (TISEPP). Where works do not require development consent but require approval of a Government organisation under any legislation, then they are defined as an activity under Part 5 of the EP&A Act. Division 5.1 and Section 5.7 of the EP&A Act requires any such Government body to determine whether the impacts of the activity are likely to be significant. A FFA contributes to that determination.

A FFA is prepared, to inform a Review of Environmental Factors, to meet the requirements of Clause 171 of the *Environmental Planning and Assessment Regulation 2023*.

6.1.1 State Environmental Planning Policy (Transport and Infrastructure) 2021

The State Environmental Planning Policy (Transport and Infrastructure) 2021 (TISEPP) provides for the efficient provision of public infrastructure in NSW. The aim of this Policy is to facilitate the effective delivery of infrastructure across the State.

6.2 Water Management Act 2000

The Water Management Act 2000 (WM Act) provides for the sustainable and integrated management of the water sources of the State for the benefit of both present and future generations. The WM Act defines principles of water management, sets out water licensing laws and environmental water provisions.

Section 91 (2) states that: waterfront land means—...where the prescribed distance is 40 metres or (if the regulations prescribe a lesser distance, either generally or in relation to a particular location or class of locations) that lesser distance.

This project is being carried out further than 40 metres from waterfront so is exempt from requiring a Controlled Activity Approval in accordance with the WM Act.

6.3 Biodiversity Conservation Act 2016

The Biodiversity Conservation Act 2016 (BC Act) includes the Biodiversity Offsets Scheme (BOS) that governs how biodiversity offsets will be used to ensure they offset the loss due to development and deliver conservation outcomes. The Act and Regulations also govern the Biodiversity Assessment Method (BAM) as a scientific method that assesses biodiversity losses from impacts at development sites and gains from conserving land at stewardship sites.

Public authorities seeking to undertake an activity under Part 5 of the EP&A Act can voluntarily opt-in to the BOS and BAM scheme, or alternatively can elect to undertake an Assessment of Significance and proceed with a Part 5 approval. It will be required to:

- take serious and irreversible impacts into consideration; and
- determine if there are any additional and appropriate measures that will minimise the impact if the activity is to be carried out or approved.
- The potential ecological impacts of the proposal are discussed in Section 9 of this FFA.



6.4 Environment Protection and Biodiversity Conservation Act 1999

Under the Commonwealth Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act), Commonwealth approval is required for certain actions. Actions which have or may have or are likely to have a significant impact on Matters of National Environmental Significance (MNES). MNES include nationally threatened species or endangered ecological communities. Under the EPBC Act an assessment of the impact of a proposal on a MNES must be undertaken to determine whether there is likely to be a significant impact. If the assessment concludes there is a significant impact, then it will become a controlled action under the EPBC Act and the proposal must be referred to the Commonwealth. Approval from the relevant Federal Minister is also required for any actions that may have a significant impact on matters of National Environmental Significance, except in circumstances which are set out in the EPBC Act.

Approval from the Commonwealth is in addition to any approvals under NSW legislation.

The potential ecological impacts of the proposal are discussed in Section 9 of this FFA. It is concluded that the proposal is not likely to have a significant impact on any EPBC listed threatened species, populations or communities nor is it likely to impact on any MNES and so does not require referral to the Commonwealth under the EPBC Act.

6.5 Parramatta Local Environmental Plan 2023

The *Parramatta Local Environmental Plan 2023* (LEP) current version came into effect on 18 August 2023. This plan aims to make local environmental planning provisions for land in the Parramatta LGA in accordance with the relevant standard environmental planning instrument.

The works are to be conducted as per LEP zoned land. The objectives of this zone include:

- To provide for infrastructure and related uses.
- To prevent development that is not compatible with or that may detract from the provision of infrastructure.
- The proposed works are compliant with the objectives of this zoning, as it will provide new school infrastructure at the site.

6.6 Parramatta Development Control Plan 2011 – As amended 13 Mar 2020

The aim of the *Parramatta Development Control Plan 2011* (DCP) is to allow detailed provisions to be made to control and guide development and subdivision within the Parramatta LGA.

Several additional Development Control Plans may apply to the subject, including:

7 EXISTING ENVIRONMENT

7.1 Existing Environment

The subject site encompasses an area of approximately 9471m², (Figure 5-1). Melrose Park High School is a cleared lot with no buildings and no trees. Outside the site, there are native trees along the eastern side near the Wharf Road boundary.

7.1.1 Desktop search

Prior to undertaking the ecological field survey, desktop searches were conducted to provide a context of the surrounding environment.

7.1.2 Vegetation communities

A review of the vegetation mapping databases using the SEED portal (NSW Government's central resource for Sharing and Enabling Environmental Data in NSW) was undertaken to identify Plant Community Types (PCTs) present within the area. As indicated in Figure 7-1, no PCTs were mapped as being present within the project site.

Analysis of high-resolution satellite imagery indicated that no native eucalyptus trees are present on the subject site. Previously, the site was occupied by a large building, which has since been demolished and cleared.

Historic photographs from 1943 revealed the trees adjacent to the site boundary were planted and are not remnants of native vegetation (Figure 7-2).

7.1.3 Threatened Species

A search of the DCCEEW BioNet Atlas revealed 4,270 records of 68 listed species were previously recorded within 10 km of the site. Analysis of the Protected Matters Search Tool indicated 13 listed threatened ecological communities, 111 listed threatened species, and 59 listed migratory species previously recorded within 10 km of the subject site. No World Heritage Properties, National Heritage Places, Protected Marine Areas, nor Wetlands of international importance occurred within 10 km of the site (Appendix A).

The DCCEEW BioNet Atlas mapping identified two endangered or threatened species near the site, including *Pteropus poliocephalus* (Grey-headed Flying-fox), and the White-bellied Sea Eagle (*Haliaeetus leucogaster*). The Likelihood of Occurrence analysis indicated the Grey-headed Flying-fox had low likelihood to occur within the site, and the White-bellied Sea Eagle had a low likelihood to occur within the site (Appendix B).

The subject site was not mapped as containing any Key Fish Habitat, nor is it in proximity to significant waterways or waterfront land, thus no further provisions within the FM Act and WM Act are not required for the proposed development.

Due to the cryptic and nocturnal nature of many species, the fauna assessment primarily evaluated the site's potential as habitat. The precautionary principle was adopted, assuming the presence of threatened species if suitable habitat exists.

7.1.4 Supporting Documents

An arboricultural impact appraisal was conducted by Naturally Trees report (2024) to assess the impact of the activity on the trees on the site (Appendix C). The appraisal determined that the activity would have no adverse impact on the trees if appropriate protective measures are taken.

7.2 Site Visit

On 6 November 2024, ecologist Petra Arola conducted a site assessment for Melrose Park High School, involving a walkthrough of all accessible vegetated areas.

An opportunistic fauna survey included searches for proxy evidence of fauna activity such as tree scratches, scats, and bird nests. As many faunal species are cryptic and/or nocturnal, they are unlikely to be detected during a short survey. The fauna assessment is largely an assessment of the potential of the site as habitat for various fauna species. Apart from species recorded at the site there is no certainty as to the presence or absence of the species discussed. Therefore, it is important to adopt the precautionary principle, it is assumed that any threatened species are likely to occur at the site if suitable habitat exists.

An assessment of potential habitat features for threatened species, such as tree hollows or crevices in tree bark was also conducted.

7.2.1 Flora

The vegetation on site did not represent any nearby PCTs. The native canopy vegetation present outside the site boundary consisted of five large native trees including spotted gum (*Corymbia maculata*). Figure 7-4 shows the trees at the site and their relative Tree Protection Zones (TPZs). Table 7-1 shows the Tree Inventory Relative to Proposed Site Boundary. Some of the trees outside the site boundary have TPZs within the Site.

These trees occurred along the boundary fence line at Wharf Road. No large, continuous patches of vegetation were present. The subject site was extensively cleared. Analysis of historic images from 1943 indicated that the trees present are most likely planted (Figure 7-2). The canopy trees were isolated from each other by large areas of managed grassland. No trees will be impacted by the proposed activity.

7.2.2 Fauna

The fauna survey did not find potential nesting or roosting habitat such as stick nests or tree hollows within the subject site. Five isolated canopy trees are present adjacent to the eastern boundary fence off the site (Figure 5-1). These did not possess any habitat features such as nests or hollows, and are not likely used by any threatened fauna species. No significant landscape features such as caves, culverts, rivers, or waterbodies were present.

8 SIGNIFICANCE OF ENVIRONMENTAL IMPACTS

Based on the identification of potential issues, and an assessment of the nature and extent of the impacts of the proposed activity, it is determined that:

- The extent and nature of potential impacts are low and will not have significant impact on the locality, community and/or the environment.
- Potential impacts can be appropriately mitigated or managed to ensure that there is no significant impact on the environment.

No threatened flora or fauna species are considered highly likely to occur within the subject site. The terrestrial flora and fauna survey was limited to less than one hour. The field survey was restricted to the area of impact of the proposed works.

As there were no threatened species nor habitat to support these species found, a Test of Significance was not required. As many faunal species likely to occur within the project area are cryptic and/or nocturnal, or may only visit the site on occasion, they are unlikely to be detected even during seasonal surveys. The fauna assessment is, accordingly, largely an assessment of the potential of the project site as habitat for various fauna species. Therefore, it is important to adopt the precautionary principle such that it is assumed that threatened species may be at the site if suitable habitat exists.



9 POTENTIAL IMPACTS

9.1 Construction Impacts

The following is a summary of the direct and indirect impacts to the biodiversity potentially persisting onsite.

9.1.1 Vegetation

The proposal does not involve the removal of any trees; all existing trees are outside the site boundary and will be incorporated into the Wharf Road Reserve (refer to Figure 9-1 for proposed plans and





for the Constraints map). The constraints map highlights 'no go zones' in red, areas which should not be impacted by construction.

The proposal revealed that there are no trees scheduled for removal. Instead, all trees, located primarily without the eastern side of the site, will be retained and protected. These trees are in good condition and hold significant value, contributing to the site's existing canopy coverage, which will be preserved. Activities will take



place outside the Tree Protection Zones (TPZs) of these established native trees to prevent any damage. Refer to Figure 7-4 for TPZs and Table 7-1 for a tree inventory.

The arboricultural method statement (Naturally Trees report 2024) outlined the necessary precautions to protect the trees, including tree protection fencing, ground protection, working within the TPZ, and a schedule of works and responsibilities. The arboricultural impact appraisal concluded that with these protective measures, the proposed activity could proceed without adversely affecting the trees on site (Appendix C).

The proposed activity may impact nine high-category and two low-category trees by disturbing their TPZs during construction activities such as the removal and installation of surfacing, structures, and landscaping (Figure 9-3). A 3% incursion into the TPZ of Tree 3 is deemed acceptable according to the Australian Standard Protection of Trees on Development Sites (AS4970-2009).

Referring to the Naturally Trees (2024) arborist assessment the proposed path will affect the TPZs of Trees 2, 3, 4, and 5, necessitating a footpath design that accommodates tree roots. A suspended timber or steel structure is recommended to prevent impacts. Trees 8 and 9, being low category, are outside the proposed works area. With the proper precautions detailed in the arboricultural method statement, the activity should not adversely impact the trees or their contribution to local amenity or character (Appendix C).

9.1.2 Grey-headed Flying-fox

The noise, light, and increased human presence from construction activities may disrupt the foraging behaviour of the Grey-headed Flying-fox and deter them from using the site and surrounds. Additionally, any removal of flowering native trees, which serve as important feeding habitats, could reduce the availability of food resources, thereby affecting their feeding patterns and overall health.

9.1.3 Contractors and Staff Inductions

Induction of all contractors and staff outlining the ecological sensitivity of the site, the need to minimise ecological impact, and all other required mitigation measures is to be undertaken.

9.1.4 Hygiene

Basic hygiene protocols would be implemented for construction personnel and machinery on site to reduce the potential for invasion by plant pathogens including *Phytopthora cinnamomi*, the fungus myrtle rust *Uredo rangelli* and amphibian chytrid fungus.

10 CONCLUSION AND RECOMMENDATIONS

Subject to implementing the recommendations/mitigation measures set out below and in Section 9.1.5 of this report, the conclusion of this assessment is that the proposed Activity is not likely to significantly affect the environment in relation to ecological matters.

There are no trees within the site; however, trees along the site boundary may extend into the area, with their drip lines encroaching on the site. As a precautionary measure, potential impacts on these trees should be considered. Activities within the tree TPZs will require precautions to avoid damage, with a qualified arborist overseeing the process and providing a Tree Protection Plan. Contractors and staff will be inducted on the site's ecological sensitivity, and basic hygiene protocols will be implemented to prevent plant pathogens and fungi.

If these mitigation measures are followed, the ecological impact of the construction can be minimised, ensuring the protection of the remaining trees and local wildlife.

This FFA for the Melrose Park High School has assessed the potential environmental impacts of the proposed activity. The assessment, conducted by Water Technology, found no significant biodiversity areas or threatened species on the site that cannot be mitigated. Consequently, the project will not cause significant environmental impacts, and no further referral or Environmental Impact Statement is required. This conclusion supports the progression of the redevelopment project under the current planning and environmental regulations, ensuring that the school infrastructure can proceed with minimal biodiversity disruption.

3 DATA SOURCES

Threatened ecological communities

For threatened ecological communities where the distribution is well known, maps are generated based on information contained in recovery plans, State vegetation maps and remote sensing imagery and other sources. Where threatened ecological community distributions are less well known, existing vegetation maps and point location data are used to produce indicative distribution maps.

Threatened, migratory and marine species

Threatened, migratory and marine species distributions have been discerned through a variety of methods. Where distributions are well known and if time permits, distributions are inferred from either thematic spatial data (i.e. vegetation, soils, geology, elevation, aspect, terrain, etc.) together with point locations and described habitat; or modelled (MAXENT or BIOCLIM habitat modelling) using

Where little information is available for a species or large number of maps are required in a short time-frame, maps are derived either from 0.04 or 0.02 decimal degree cells; by an automated process using polygon capture techniques (static two kilometre grid cells, alpha-hull and convex hull); or captured manually or by using topographic features (national park boundaries, islands, etc.).

In the early stages of the distribution mapping process (1999-early 2000s) distributions were defined by degree blocks, 100K or 250K map sheets to rapidly create distribution maps. More detailed distribution mapping methods are used to update these distributions

4 LIMITATIONS

The following species and ecological communities have not been mapped and do not appear in this report:

- threatened species listed as extinct or considered vagrants;
- some recently listed species and ecological communities;
- some listed migratory and listed marine species, which are not listed as threatened species; and
- migratory species that are very widespread, vagrant, or only occur in Australia in small numbers.

The following groups have been mapped, but may not cover the complete distribution of the species:

listed migratory and/or listed marine seabirds, which are not listed as threatened, have only been mapped for recorded
seals which have only been mapped for breeding sites near the Australian continent

The breeding sites may be important for the protection of the Commonwealth Marine environment.
