Good morning Carmen,

I have briefly reviewed the proposed development plans.

The land is zoned R3 Medium Density under Penrith LEP 2010 and the scale of the proposed development is not compatible with the existing or desired future character of the area under the objectives of this zone creating impacts to existing residents. Such a proposal would be better located in the nearby R4 High Density Residential zone under the LEP.

Notwithstanding this, it is acknowledged that the proposal is being progressed as development without consent under *State Environmental Planning*

Policy (Housing) 2021 which prevails to the extent of an LEP inconsistency and is being assessed by Homes NSW under Part V of the Environmental Planning and Assessment Act, 1979.

It is therefore trusted that the proposal has been designed and the assessment will ensure that any resulting impacts of the inherent scale incompatibility introduced by this development are minimised.

Dear Resident(s),

I am writing to you from Homes NSW to update you about our plans to redevelop the housing site at 16,17,18 Stapleton Parade, St Marys and seek your feedback on our detailed design.

What we are proposing

We are proposing to redevelop the vacant site with a new 2-3 storey seniors' housing development which will include:

- 18 homes in total 10 x 1 bedroom units and 8 x 2 bedroom units
- 8 on-site underground car parking spaces
- landscaping and fencing across the site

What we have done so far

In December 2023 we invited the community to provide preliminary feedback about the proposal. The key themes raised in feedback received related to privacy, property values, onsite parking, and street traffic.

In response to this feedback, I can confirm:

- Visual and acoustic impacts on neighbouring properties will be minimised through building setbacks, fencing, privacy screens, careful window placement and landscaping, including screen plantings at the side and rear boundaries.
- The proposed development is designed to seamlessly blend in with its surroundings and enhance the existing character of the area. There is no evidence to suggest the development would adversely affect property values.
- These Homes NSW owned sites have been selected for renewal because of their easy access to public transport, goods, and services such as on Queen Street, St Marys. This convenient location means tenants will not have to rely on owning a car. The proposal provides 8 car parking spaces which is consistent with the requirements of the State Environmental Planning Policy (Housing) 2021 (Housing SEPP).





• A traffic and parking assessment has been completed and finds that the new development is not expected to have any significant impacts on the local street network or parking.

What is happening now?

We have recently completed a detailed design process for 16,17,18 Stapleton Parade, St Marys. We invite your feedback, which will be carefully considered by our design and planning team as part of the assessment of this project and where possible we will incorporate your feedback in the designs.

- site and landscape plan
- building elevations
- proposed materials and colour finishes
- shadow diagrams.
