This report is in response to the WWCC RFI questions (15th December 2022) following on from the briefing with the planning panel.

In this response, the numbers/figures that relate to the future have been estimated based on past and current data. Also the figures facture in the approval of the proposed development will attract more members from surrounding areas to reside in and around Wagga Wagga.

In 2003, the congregation in Wagga was 25 people. In 2022 the congregation grew to approximately 215 people. It is anticipated that the congregation will grow to 350 people around 2040, and approximately 400 people around 2047.

Some special occasion events will only be held within the Services Building temporarily as part of the stage 1 development. They will then be held within the Church once Stage 2 is complete. The 2022 frequencies reflect the current frequency of special occasions within the current building.

The "feasts" the Coptic Church will have are Christmas & Easter. These are solely a liturgical church service, but as part of stage 1 will be in the Sunday School Services Building. On the day of each feast for two hours, the congregation will have a Sunday School Celebration. This will involve the Sunday school children performing hymns and presenting plays of which they have learned throughout the year to the congregation only. It's not open to the public.

Passion Week is all liturgical prayers. These will be in the Sunday School Service Building as part of stage 1 and will move to the church upon completion of Stage 2. Nothing will take place in the Sunday School Service Building during Passion week when the future church is operational.

The congregation will also use the Sunday School Service Building for Sunday school performances which are on the two feasts previously mentioned and one further celebration being as a "reward" presentation to give the Sunday school children their annual gifts. These three celebrations replace Sunday school in these days and go for about 2 hours.

'Special occasion' yearly events



Please note - As part of the Coptic Church development, the context of the word 'feasts' is solely a liturgical church service.

In addition to the yearly events outlined in table 3 there will be circumstantial events throughout the year such as baptisms, wedding ceremonies and funerals.

Baptisms - The current congregation have around 1 to 2 baptisms per year. This is expected to increase as the congregation grows. With a future congregation of 400 the prediction would be 3 to 4 baptism per year. Refer to table 4.

Wedding Ceremonies - The current congregation have around 1 wedding ceremony per year. This is expected to increase as the congregation grows. With a future congregation of 400 the prediction would be 2 wedding ceremonies per year. Refer to table 5.

Funerals - The current congregation have around 1 funeral every 3 years. This is expected to increase as the congregation grows. With a future congregation of 400 the prediction would be 2 funerals every 3 years. Refer to table 6.

The open nature of the proposed Sunday School Service Building allows the space flexibility to be used as a multipurpose area. During Stage 1 different seating zones will divide the space to cater for both meals and church service concurrently. In practice this space will seat 150 people evenly between church service and meal activity. The Sunday School Service Building will cater for growth in the congregation, however it is not the intention to seat 400 people in this space. By the time the numbers have reached this figure the future church will be in use.

During the transition phase of the development (between stage 1 & stage 2) the Coptic Church congregation will have procedures in place to manage the weekly operations of the different seating arrangements to cater for the growing congregation. At this time the space will be divided between church seating and table seating. If the active congregation exceeds the seating area provided for the church service division (stage 1) before stage 2 is completed the process will simply involve swapping out some of the tables for extra chairs during the service then bringing the removed tables back after commencement of the service to cater for the following meal.

Below are tables outlining the nature of both baptisms and wedding ceremonies for the current congregation size up to the expected future growth in congregation in 25 years. The number of persons has been based on the expected maximum size of future congregation as part of this development.

Baptisms will be in the Sunday School Service Building as part of stage 1 and will move to the church upon completion of Stage 2. The baptismal prayers are conducted before the Liturgy (from 7am to 8:15am). The liturgy follows from 8:15am to 11:15am. After praying the baptismal prayers and

Liturgy, the congregants will have a usual breakfast meal just like any Sunday. Our baptisms are always on either a Saturday or Sunday, and again are restricted to the congregants.

Completion of stage 2 - After praying the baptismal prayers and Liturgy inside the church, the congregants go to the Sunday School Service Building to have a usual breakfast meal just like any Sunday.

As part of stage 1 Wedding Ceremonies will be in the Sunday School Service Building. The Coptic Church congregation do not use the Sunday School Service Building for any subsequent wedding celebration as the congregants hire their own wedding receptions external to the church.

The table below outlines the nature of funeral events for the current congregation size up to the expected future growth in congregation in 25 years. The number of persons has been based on the expected maximum size of future congregation as part of this development. The process will involve using the Sunday School Service building for the 'wake' (vigil) being for the departed souls on the night before the funeral day. The 'wake' is for the congregation to come into the Sunday School Service Building where they listen to recorded sermons and then the parish priest gives a comforting word. The body of the deceased person is not in attendance as all these arrangements take place at the funeral home, external to the church altogether.

As part of stage 1 The Wake (night before) and Funeral will be in the Sunday School Service Building.

Completion of stage 2 - The Wake (night before) will be in the Sunday School Service Building. Funerals will take place in the church itself.

LEP definition – Funeral home:

'means premises that are used to arrange, conduct and cater for funerals and memorial services, whether or not the premises include facilities for the short-term storage, dressing and viewing of bodies of deceased persons.'

The anticipated funeral use in relation to the LEP definition is the proposed development will serve as a premise to arrange, conduct and cater for funerals. The body of the deceased one comes from the designated funeral home on the day of the funeral and goes inside the church (at stage 1 this will be in the Sunday School Services building) for prayers. This takes place for about an hour then the deceased body is moved to the Hurst waiting outside and transported away.

Applying the Funeral Home definition, the premise does undertake aspects of a funeral home. Funeral homes are not included within the prohibited uses in R1 zone and therefore are permitted with consent.

The Coptic Church development is not a premises seeking the business that provides the dressing, storage or burial of the deceased body.

In reference to table 7 above, after completion of the new church in stage 2 all Liturgical events will be shifted across from the Sunday School Services Building to the church. This includes the main Sunday service, the special occasion liturgical church services, liturgical prayers and Baptisms, wedding ceremonies and funeral services.

The font will be relocated to this new church building and the Sunday School Service Building will be modified to include a stage and changerooms at the eastern end for Sunday School performances.

The previously divided seating area within this space (as part of stage 1) will be freed up to seat the larger congregation for meals, without the need for swapping out chairs and tables. The Sunday School Service Building will still continue as a multipurpose facility catering for the weekly congregation breakfast, Sunday School Performances, Wakes, special occasion meals and storage

Without the need for Liturgical events the Sunday School Service Building is freed up to provide a large indoor space for Sunday School children's activities.
