**NOTICE OF EXHIBITION OF DEVELOPMENT APPLICATION DA 22/1842
DIGITAL ADVERTISING SIGNAGE
GORE HILL FREEWAY, ARTARMON**

Reference is made to Department of Planning and Environment (DPE) email dated 13 April 2022, regarding the abovementioned application which was referred to Transport for NSW (TfNSW) for concurrence under section 138 of the *Roads Act 1993*

TfNSW has reviewed the submitted application and provides concurrence under section 138 of the *Roads Act 1993* subject to the following conditions being included in any approval issued by the Department:

1. The proposed signs design and operation shall be in accordance with the Transport Corridor Outdoor Advertising and Signage Guidelines 2017 requirements.
2. The images displayed on the sign must not contain/use:
 - Flashing or flickering lights or content
 - Animated displays, moving parts or simulated movement
 - Complex displays including text and information that hold a driver's attention beyond "glance appreciation"
 - Displays resembling traffic control devices by use of colour, shape or words that can be construed as giving instruction to traffic for example, red, amber, or green circles, octagons, crosses, triangles, and words such as 'stop' or 'halt'
 - A method of illumination that distracts or dazzles; and
 - Dominant use of colours red or green.
3. Dwell times between displays shall be no shorter than 25 seconds.
4. The Applicant shall prepare an independent Road Safety Assessment (RSA) After 15 months of operation of the digital signage. The RSA should provide a formal assessment of the safety performance of the sign particularly on road users along the subject section of the Freeway.
5. Upon completion of the RSA, it is to be provided to TfNSW for review. The Applicant will be required to implement the recommendations of the RSA to ensure that road safety is maintained along Gore Hill Freeway.
6. A Road Occupancy Licence (ROL) should be obtained from Transport Management Centre for any works that may impact on traffic flows on the subject section of Gore Hill Freeway during construction activities. A ROL can be obtained through <https://myrta.com/oplinc2/pages/security/oplincLogin.jsf>.
7. All costs associated with the proposed sign, including maintenance activities, shall be at no cost to TfNSW.
