### **Reasons for decision**

The following matters were taken into consideration in making this decision:

- the relevant matters listed in section 4.15 of the Act and the additional matters listed in the statutory context section of the Department's Assessment Report;
- the prescribed matters under the Environmental Planning and Assessment Regulation 2021;
- the objects of the Act;
- all information submitted to the Department during the assessment of the development application;
- the findings and recommendations in the Department's Assessment Report; and
- the views of the community about the project (see Attachment 1)

The findings and recommendations set out in the Department's Assessment Report were accepted and adopted as the reasons for making this decision.

The key reasons for granting consent to the development application are as follows:

- the project is permissible with development consent under the State Environmental Planning Policy (Industry and Employment) 2021 and is consistent with NSW Government policies including the Transport Corridor Outdoor Advertising and Signage Guidelines (the Guidelines) with the aim to achieve best practice for the planning and design of outdoor advertisements in transport corridors. The proposal supports this aim by ensuring the proposal does not have any significant impacts on the surrounding area;
- the impacts on the community and the environment can be appropriately minimised, managed or offset to an
  acceptable level, in accordance with applicable NSW Government policies and standards including the limiting
  of the brightness of the sign and allowing the usage of the sign for public announcements and public
  emergencies.
- the issues raised by the community in submissions have been considered and adequately addressed through changes to the project and the recommended conditions of consent (where applicable); and
- weighing all relevant considerations, the project is in the public interest.

### Attachment 1 – Consideration of Community Views

The Department exhibited the Development Application for the project, including the Statement of Environmental Effects from 10 May 2022 until 6 June 2022 (28 days) and again form 15 June 2022 until 28 June 2022 (14 days) due to an unforeseen change in the exhibition webpage on the Planning Portal. The Department received 2 submissions (both objections) from the local Council and a community member.

The key issues raised by the community and considered in the Department's Assessment Report and by the decision maker include design and suitability of the site, visual impact and illumination. Other issues raised by the local Council are addressed in detail in the Department's Assessment Report.
