Description of proposal

Excavation/trenching for the main services alignment, and two pipe laterals off main services alignment; installation of PVC water main pipeline and electrical conduit; installation of two pipe laterals, including two fire hydrants and end caps; backfilling trench with sand, compacted crushed rock, and reinstatement of pavement with asphalt; and site rehabilitation and stabilisation.

Nominated Integrated Development

The proposal is classed as integrated development under the *Environmental Planning and Assessment Act 1979* as approval is required from the Department of Planning & Environment - Water under section 91 of the *Water Management Act 2000*.
