# **Telecommunications Facilities at Penrith Lakes**

### **Description of development**

The application seeks consent for the installation of new telecommunication facilities at Penrith Lakes consisting of:

- Two (2) new Optus 9.23m Smart Poles;
- Two (2) new Optus small cell antennas mounted within each of the proposed new Smart Poles;
- Underground electrical and fibre works associated with the proposed Smart Poles; and
- Ancillary equipment associated with the operation of the facility, including but not limited to earthing and electrical works.

The application is nominated integrated development, requiring an approval from DPE Water under Section 91 of the Water Management Act 2000 as the proposed development is defined as a controlled activity.
