Description of development

The application seeks consent for alterations and additions to the Carrington Engine House associated with restoration of the building. This includes sub-floor works, a new concrete slab and services in within the Engine Room, asbestos containment works, construction of an accessible entry ramp to the building, a roof mounted solar photovoltaic system and interpretive landscaping features.

The application is classified as nominated integrated development as it requires an approval from Heritage NSW pursuant to Section 58 of the *Heritage Act 1997* due to the proposed works on the building/place and it being listed on the State Heritage Register.

The application is also integrated development as it requires an approval from Subsidence Advisory NSW pursuant to section 22 of the *Coal Mine Subsidence Compensation Act 2017*.
