Decision

Reasons for decision

The following matters were taken into consideration in making this decision:

- the relevant matters listed in section 4.15 of the Act and the additional matters listed in the statutory context section of the Department's Assessment Report;
- the prescribed matters under the Environmental Planning and Assessment Regulation 2021;
- the objects of the Act;
- all information submitted to the Department during the assessment of the development application and any additional information considered in the Department's Assessment Report;
- the findings and recommendations in the Department's Assessment Report; and
- the views of the community about the project (see Attachment 1).

The findings and recommendations set out in the Department's Assessment Report were accepted and adopted as the reasons for making this decision.

The key reasons for granting consent to the development application are as follows:

- the project is permissible with development consent under the State Environmental Planning Policy (Precincts

 Regional) 2021 and is consistent with NSW Government policies including the South East and Tableland
 Region Plan 2036 aim to increase visitation to NSW ski resorts;
- the impacts on the community and the environment can be appropriately minimised or managed to an
 acceptable level, in accordance with applicable NSW Government policies and standards. The consent
 authority has imposed conditions relating to construction standards, environmental considerations, post
 construction certification and rehabilitation;
- the issues raised by the community during consultation and in submissions have been considered and adequately addressed by the Applicant and in the Department's Assessment Report; and
- weighing all relevant considerations, the project is in the public interest.

Attachment 1 – Consideration of Community Views

The Department's Community Participation Plan (November 2019) prepared in accordance with Schedule 1 of the EP&A Act required the development application to be exhibited for a period of fourteen (14) days. The Department extended the exhibition period to twenty-eight (28) days as the proposal is similar to the erection or extension of a new ski-lift line, for which the CPP indicates an exhibition period of twenty-eight (28) days, and the extended exhibition timeframe was considered to be consistent with the public interest. The exhibition was also extended by a further four (4) days as a result of technical issues with the Planning Portal website that meant it was inaccessible by the public. The Department exhibited the application between 5 September 2022 and 7 October 2022 on the NSW Planning Portal and notified all lodges within Thredbo Village of the works.

The application was also forwarded to the NPWS pursuant to (former) section 4.15 of the Precincts - Regional SEPP. Comments received from the National Parks and Wildlife Service are addressed in detail in the Department's Assessment Report.

Two (2) public submissions were received objecting to the proposal. The key issues raised in the submissions are considered in the Department's Assessment Report and by the decision maker, which relate to concern that the amusement ride of this scale is not appropriate in a National Park and that there will be adverse impacts on the environment and Thredbo community. The issues are addressed in detail in the Department's Assessment Report and tabulated below.

While minor trimming of BVM vegetation may be required, this has been assessed and considered by the NPWS in their assessment of impacts on vegetation and whether a BDAR is required or the BOS is triggered. The NPWS has confirmed that the extent of any impacts to the BVM area is minor and have been appropriately investigated in the flora and fauna study, and that the BOS has not been triggered. While the Alpine Coaster will certainly be visible from Thredbo Village vantage points, it is not considered vastly incompatible with the various types of linear ski slope infrastructure already visible in the same precinct or unduly intrusive. Assessment Additional noise from operation of the Coaster was considered acceptable given the locality within the village hub and the existing recreational activities within proximity. The Applicant has proposed operation times that restricts the use of the facility to 8:30 am – 4:30 pm during winter; and 8:30 am – 4:30 pm during summer, with extensions up to 5:30 pm during holiday periods. Limiting factors to operation of the Coaster include extreme weather events (e.g. heavy rain, wind, heavy snow, bush fire and lightning). The limited times means that noise should not intrude in early morning or late evening periods of quiet repose, even though noise associated with snow-making and grooming activities will continue on slope as usual. Operational noise from the Coaster was indicated as not being dissimilar to the noise associated with the existing bobsled operation in summer and other year-round lifting operations in the resort. The consent authority is satisfied that the proposed development is acceptable. Conditions Conditions have been included that require the following to help abate and manage noise: management of the construction of the site in accordance with Australian Standard AS 2436-2010 (Guide to noise and vibration control on construction, demolition and maintenance sites) and to ensure there is no adverse impact on any neighbouring/affected tourist accommodation buildings during the construction phase of the development.

An Environmental Officer on site during works will have to inspect and verify that the environmental management measures required in the various plans are in place and operating effectively.
