Statement of Environmental Effects

Dear Mr Brown,

On behalf of our clients, Oldina Ski Lodge, we request the following amendment to the previous approval DA 9791 granted 13 August 2020. This modification is submitted under section 4.55 (1A) of the Environmental Planning and Assessment Act

Proposed Modification

We propose to modify the colour of the window frames from natural anodised aluminium (shown as Shale Grey) to Powdercoat Colorbond Monument to match the proposed metal wall cladding colour.

Approval Considerations

In accordance with the requirements of the act the following are addressed:

(a) It is Satisfied that the proposed modification is of minimal environmental impact

The proposed modification of the window frames will have minimal environmental impact as it is simply the change of the approved colour and finish for the Aluminium window Frames.

(b) It is Satisfied that the development to which the consent as modified relates is substantially the same development as the development to which the consent was originally granted

The proposed modification does not radically change the appearance or functionality of the initial approval.
