#### WORK PLAN FOR:

Demolition of dwelling the property of:

- The Demolisher will notify WorkCover seven days before start of works.
- **The Demolisher** will supply & erect a suitable temporary fence to secure the demolition site, & provide identification & warning signs before works begin.
- The Demolisher will provide mobile toilet facilities for site workers.
- **The Demolisher** will arrange to disconnect utility services from site. (Owner to contact AGL on 131 245 to have the gas meter & gas lines removed.)
- The garage will be dismantled by hand and loaded on to tipper truck.
- The works will be conducted between the hours of 7.00am. and 5.00pm. from Monday to Friday inclusive and will take 7-10 working days.

### **ENVIRONMENTAL IMPACT STATEMENT**

- All works will comply with AS 2601-2001 Demolition of Structures
- Dust will be minimised by spraying with water during demolition.
- Noise shall not exceed 10db above ambient levels during any 15 min period
- Loads will be covered before leaving the site.
- Adjacent properties & public rights of way shall be protected.
- Asbestos Fibro is removed manually by wet method, as required under WorkCover and OH&S Safety Regulations to Australian Standard 2601-2001, wrapped with plastic and placed in a dedicated truck. The truck is securely sealed and tipped at a suitably approved site.
- The roof will be removed manually.
- Garage will be demolished by hand & the site left clean and ready for the builder.
- Access & Egress to adjoining properties will be unaffected.
- The Environmental Effects will be minimal and short term.
