Description of proposed development

The proposal seeks to demolish and remove four existing static landscape signs and install one new digital portrait monopole sign on the eastern side of the Pacific Highway, Lindfield. The proposal is located opposite 350 Pacific Highway, Lindfield and adjacent to Lindfield Train Station. The proposed sign has dimensions of 3.172m x 4.708m, comprising an area of 14.93m², and the monopole structure will have an overall height of 8.29m above ground level. The proposed sign will be oriented to the south to face northbound traffic.
