Description of proposed development

Demolition of all structures, removal of 113 trees, bulk earthworks and construction and operation of a bus depot comprising:

- a two storey workshop and two storey office
- bus parking for 96 buses and carparking for 113 vehicles
- refuelling bowser
- two driveways to Racecourse Road
- associated landscaping, infrastructure works and signage
- 24 hours a day, 7 days a week operation.

The application is classified as integrated development as it requires concurrence from Transport for NSW under Section 138 of the *Roads Act 1993*.
