**RE: DIGITAL SIGN PROPOSAL FOR THE M2 EDEN GARDENS OUTBOUND  
RESPONSES TO DPE COMMENTS**

**1.0 INTRODUCTION**

We refer to:

- Dot point 2 made by DPE in Attachment A of Anthony Witherdin's letter dated 16 May 2023, which states *"Confirm whether the proposed sign and the existing advertisement sign on the western elevation of the Lane Cove Road Overpass would be visible concurrently"*
- Condition 5: The proposed sign is *"not to obstruct sight distances to any of the existing traffic signs for motorists travelling southbound on the M2 Motorway"*.

Our responses to the above points are detailed in Sections 2.0 and 3.0 respectively.

**2.0 DRIVER SIGN VIEWING RANGES**

The driver viewing range to each sign from the M2 northbound is illustrated in Figure 2.1. It clearly demonstrates that neither sign can be seen concurrently and the proposed sign will not cause any driver distraction.

### 3.0 M2 SOUTHBOUND TRAFFIC SIGN IMPACTS

A daytime photo montage of the M2 southbound between the Lane Cove Road overpass and the proposed sign is shown in Figure 3.1. The figure clearly demonstrates the proposed sign does not obstruct sight distances to any existing traffic signs for motorists given its location on the roaside and position beyond and behind the direction sign for the Delhil Road exit. Only the rear of the sign will be visible to southbound traffic. It will have no impact whatsoever to southbound traffic with essentially the same view as current.
