

Amendment of Development Application 23/3863 (PAN-313916)

Legislative Requirements

This amendment to Development Application (DA) 23/3863 (PAN-313916) is being made under Section 37 of the *Environmental Planning and Assessment Regulation 2021*.

Details of Amendment

This amendment to DA 23/3863 includes the works outlined below:

- Reinstatement of five (5) ticket windows on the Valley Terminal (VT) Guest Services building (Figure 1);
- Installation of five (5) TV screens above the ticket windows;
- Replacement of timber cladding on the underside of the VT Guest Services awning with like-for-like timber material (Figure 2).



The Guest Services building is located on the same lot as the main Valley Terminal building. The proposed amendment is largely the same as the original proposal i.e. replacement of cladding and window replacement in the areas identified above. Note, approval is not being sought for cladding and window replacement on the entire Guest Services building. The materials and colours for the proposed works will be in keeping with the existing buildings.
