Description of proposed development

The construction of a Digital Advertising Signage located on the eastern side of the Western Distributor, Pyrmont facing west bound traffic.

The Applicant proposes to surrender development consent DA 10665 granted on 1 April 2022 for a similar digital advertising sign on a monopole at Lot 9 DP 870309 located on the eastern side of the Western Distributor, south of Pyrmont Bridge Road, if this application is approved.

This is a new Development Application, with the previous application DA 22/10079 (PAN-241623) being withdrawn.

The subject site for the sign is identified as a heritage listed item on the NSW State Heritage Register as 'Pyrmont and Glebe Railway Tunnels' (SHR no. 01255). Therefore, the application for the sign is nominated integrated development requiring approval from The Heritage Council of NSW, under Section 58 of the Heritage Act 1977.
