Transport for NSW has received a Development Application (DA) from Lendlease (Millers Point) Pty Limited (C/- Mr J Riordan) for the installation of a public artwork within Watermans Cove, Barangaroo South, in the Darling Harbour waterway. The artwork is titled Monuments for Fishes, is by the artist Mikala Dwyer, and will comprise five (5) fishing float like sculptures and will be embedded into the seabed.
