#### Description of the development consent

The development application (DA 9876) was approved on 31 March 2022 by the Land and Environment Court.

The approved works comprise:

- Torrens title subdivision of three lots into four environmental lots and one residual lot;
  - subdivision of the residual lot into 93 Community title lots and one community association lot;
  - thirteen (13) development stages;
  - earthworks to achieve the final site levels and landscaping works;
  - construction of internal roads, including a slip lane to Old Castlereagh Road, footpaths and shared pathways and infrastructure to be dedicated to Council; and
  - freestanding advertisement signage.

#### Description of proposed modification

The modification seeks to amend the construction hours permitted under the development consent to allow for 24-hour construction works and also to include replacement fencing along the north-eastern boundary.
