#### Description of the proposal as now amended

Subdivision of the Thredbo Golf Course including vegetation clearing, earthworks, establishment of 18 lots, golf course re-design, construction of an access road and parking, provision of services to the allotments, site rehabilitation and landscaping works.

#### Nominated Integrated Development / Integrated Development

The proposal is classed as **nominated integrated development** under the *Environmental Planning and Assessment Act 1979* as approval is required from the Department of Climate Change, Energy the Environment and Water (DCCEEW) - Water under section 91 of the *Water Management Act 2000* and DCCEEW – Environment and Heritage under section 90 of the *National Parks and Wildlife Act 1974*. The proposal is also classed as **integrated development** requiring approval from the NSW Rural Fire Service under section 100B of the *Rural Fires Act 1997*.

#### About the exhibition

The Department of Planning, Housing and Infrastructure (the Department) has received an application to amend a development application for the abovementioned proposal. The Department has formally accepted the request to amend the application and therefore is undertaking an exhibition of the amended application.

At the time of publishing this advertisement, the Minister for Planning has not directed that a public hearing should be held.
