Prior to the issue of the relevant occupation certificate, the Applicant must submit documentation to be Principal Certifier to demonstrate that the works have been undertaken in accordance with the relevant conditions of the bush fire safety authority (reference 17 <u>24</u> in Condition A.2) <u>and</u> <u>general terms of approval (reference 17 in Condition A.2)</u>. A copy of the documentation is to be submitted to the Secretary or nominee with the occupation certificate documentation.
