Reasons for decision

The following matters were taken into consideration in making this decision:

- the relevant matters listed in section 4.15 of the Act and the additional matters listed in the statutory context section of the Department's Assessment Report;
- the prescribed matters under the Environmental Planning and Assessment Regulation 2021;
- the objects of the Act;
- the relevant matters set out in s.7.13 of the Biodiversity Conservation Act 2016;
- all information submitted to the Department during the assessment of the development application and any additional information considered in the Department's Assessment Report;
- the findings and recommendations in the Department's Assessment Report; and

The findings and recommendations set out in the Department's Assessment Report were accepted and adopted as the reasons for making this decision.

The key reasons for granting consent to the development application are as follows:

- the proposal is permissible with development consent under State Environmental Planning Policy (Industry and Employment) 2021 and is consistent with NSW Government policies including the Transport Corridor Outdoor Advertising and Signage Guidelines (Department of Planning and Environment, 2017);
- the impacts on the community and the environment can be appropriately minimised, managed or offset to an
 acceptable level, in accordance with applicable NSW Government policies and standards. The consent
 authority has imposed conditions relating to compliance with applicable Australian Standards, construction
 standards and certification, environmental considerations, and maintenance requirements;
- the issues raised by Transport for NSW and Cumberland City Council during consultation have been considered and adequately addressed through recommended conditions of consent; and
- · weighing all relevant considerations, the proposal is in the public interest.

Attachment 1 - Consideration of Community Views

The Department exhibited the development application for the proposal, including the Statement of Environmental Effects, from 11 June 2024 until 2 July 2024 (21 days) on the NSW Planning Portal. The Department also notified surrounding landholders in writing, Cumberland City Council and Transport for NSW.

No issues were raised and no submissions were made by the community during the exhibition of the proposal.

Cumberland City Council advised that it supported the proposal subject to ensuring the signage will not produce any glare and light.

The issue of glare and illumination raised by the Council were considered in the Department's Assessment Report, which concluded the luminance levels emitted by the signs is compliant with the relevant Australian standard.
