Description of proposal

Continued operation of the existing south-facing static advertising sign on the eastern side of the M7 Motorway, Prestons, for a further 15-year period.

When making a submission you will be required to include / complete the following fields under 'Make a Submission':

- your name and address and mark whether you wish for your name to be withheld
- the name of the application and the application number
- indicate whether you 'support' or 'object' to the proposal or if you are simply providing comment.
- the reasons why you support or object to the proposal
- a declaration of any reportable political donations you have made in the last two years (visit <u>www.planning.nsw.gov.au/Assess-and-Regulate/Development-Assessment/Planning-Approval-Pathways/Donations-and-Gift-Disclosure</u> or phone 1300 305 695 to find out more)
- an acknowledgement that you accept the department's disclaimer and declaration.
