4.0 PROPOSED ONGOING WASTE DISPOSAL MANAGEMENT

Waste management will be the responsibility of the occupier of the building as follows:

- 1 general waste and 1 recycling bins will be stored outside of the building, with a designated waste area for the tenancy.
- The manager is to be responsible for sorting of waste into general waste and recyclable waste.
- **5** smaller bins stored on site for daily general waste which are transferred to the larger collection bins on site on a needs basis.
- Bins to be collected **between 3-7 times a week** by Kosciuszko Thredbo.
