1 Introduction

This Modification Application (MOD) relates to Development Application (DA) 23/12108 which was granted development consent on 6 December 2023. This application is being made under section 4.55(1A) of the Act as the proposed changes to the Development are of minimal environmental impact.

1.1 Background

1.1.1 Approved Development under DA 23/12108

As per the Development Consent for 23/12108, the approved development was for works including:

- vegetation clearing;
- removal of existing snowmaking infrastructure;
- installation of snowmaking infrastructure including electricity and dialogue services;
- trenching and excavation works; and
- rehabilitation works.

2 Development components subject to this MOD

Works subject to this MOD include:

- replacement of existing hydrant with snowmaking pit and lance gun (hydrant between guns 615 and 701),
- additional trenching for snowmaking laterals, and
- increasing the construction corridor to cover the entire disturbed ski slope to allow for works to respond to unforeseen circumstances during construction e.g. unknown underground services locations.



3 Statutory Framework

The SEE (KT 2023) provided a review and assessment against key legislation and planning instruments applicable to the Development. The Development remains substantially the same as the approved development under DA 23/12108, including installation of snowmaking infrastructure, trenching and rehabilitation works. Additional statutory considerations relevant to this MOD are provided below.

3.1 Section 100 of EP&A Act – Content of a Modification Application

5 Conclusion


