Works subject to this modification include: playground upgrade to modernise existing infrastructure, pump track upgrade to be rebuilt with a slightly larger footprint, watermain upgrade to replace the current aging infrastructure and plaza paving to improve aesthetics of the area.

#### Have your say

### When making a submission you will be required to include:

- your name and address
- the name of the application and the application number
- a statement on whether you 'support' or 'object' to the proposal or if you are simply providing comment
- the reasons why you support or object to the proposal
- a declaration of any reportable political donations you have made in the last two years (visit <u>Donations</u> and <u>Gift Disclosure</u> or phone 1300 305 695 to find out more)
- an acknowledgement that you accept the department's disclaimer and declaration.
