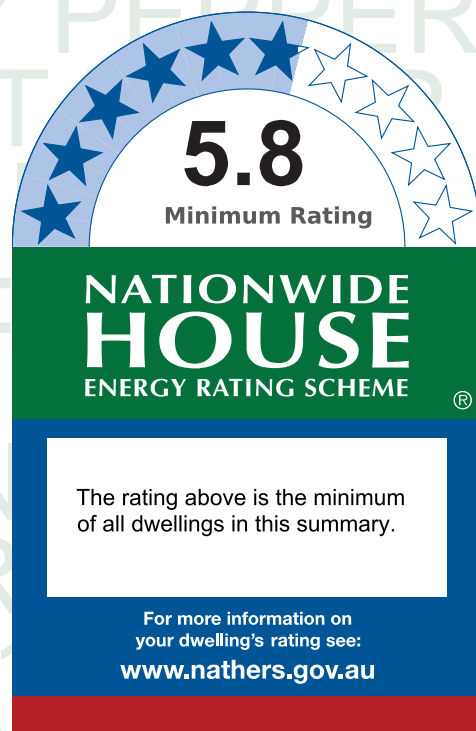

### About this report
