#### **Decision**

The Director, Trasport and Water Assessments, under delegation from the Minister of Planning and Public Spaces has, under s.4.16 of the *Environmental Planning and Assessment Act 1979* (**the Act**) granted consent to the development application subject to the recommended conditions.

#### Reasons for decision

The following matters were taken into consideration in making this decision:

- the relevant matters listed in section 4.15 of the Act and the additional matters listed in the statutory context section of the Department's Assessment Report;
- the prescribed matters under the Environmental Planning and Assessment Regulation 2021;
- the objects of the Act;
- the relevant matters set out in s7.13 of the Biodiversity Conservation Act 2016;
- all information submitted to the Department during the assessment of the development application and any additional information considered in the Department's Assessment Report; and
- the findings and recommendations in the Department's Assessment Report.

The findings and recommendations set out in the Department's Assessment Report were accepted and adopted as the reasons for making this decision.

The key reasons for granting consent to the development application are as follows:

- the project is permissible with development consent under the State Environmental Planning Policy (Industry and Employment) 2021 and is consistent with NSW Government policies including the Transport Corridor Outdoor Advertising and Signage Guidelines 2017 (Department of Planning and Environment, 2017);
- the impacts on the community and the environment can be appropriately minimised, managed or offset to an
  acceptable level, in accordance with applicable NSW Government policies and standards. The consent
  authority has imposed conditions relating to compliance with applicable Australian Standards, construction
  standards and certification, environmental considerations and maintenance requirements;
- the issues raised by Transport for NSW during consultation have been considered and adequately addressed through the recommended conditions of consent;
- no issues were raised by the community or Blacktown City Council during the public exhibition of the application; and
- weighing all relevant considerations, the project is in the public interest.

## Attachment 1 - Consideration of Community Views

The Department exhibited the development application for the project, including the Statement of Environmental Effects from 15 January 2025 to 28 January 2025 (14 days) on the NSW Planning Portal. The Department also notified surrounding landholders in writing, Blacktown City Council and Transport for NSW.

No issues were raised by the community and no public submissions were received from Blacktown City Council or the community during the exhibition period.
