Description of proposal

Earthworks, fill and retaining walls undertaken associated with providing a building pad for the water tanks and pump room and summarised as follows: Construction of a 1:2 rock stabilisation wall including rock rubble drain; placement of compacted fill to form a building pad; installation of three water tanks, each 22,500 litres in size, upsized from the DA which were 10,000 litres. Each tank is about 3.45m in diameter; installation of a pump house.

About the exhibition

An exhibition process allows any individual or organisation to have their say about a proposed development. The Department of Planning, Housing and Infrastructure (the Department) has received an application to modify a development application for the abovementioned proposal.
