To increase Crackenback Ridge water supply storage capacity to meet the demand for future development and fire protection within the locality

#### Nominated Integrated Development

The proposal is classed as integrated development under the *Environmental Planning and Assessment Act 1979* as approval is required from the Department of Climate Change, Energy, the Environment and Water (DCCEEW) under section 91 of the *Water Management Act 2000*.
