Description of proposal

Construction of mountain bike trails. The trails commence around the upper section of the Merritts Gondola lift line (also referred to as the “Schuss ski run”). The BD1 trail departs this general area, traversing the native vegetation and terminates at Friday Flat. The BD2 trail continues down the Merritts Gondola lift line and terminates when it joins the proposed Merritts Intermediate trail (subject to separate DA approval) in the locality.

About the exhibition

An exhibition process allows any individual or organisation to have their say about a proposed development. The Department of Planning, Housing and Infrastructure (the Department) has received a development application for the abovementioned proposal.

The application and accompanying documents are on exhibition from **Tuesday 4 February 2025** until **Monday 17 February 2025**. You can view these documents online at [State Development Applications](#).

At the time of publishing this advertisement, the Minister for Planning has not directed that a public hearing should be held.
