The proposal is classed as integrated development under the *Environmental Planning and Assessment Act 1979* as approval is required from the Department of Climate Change, Energy, the Environment and Water (DCCEEW) under section 91 of the *Water Management Act 2000*.

At the time of publishing this advertisement, the Minister for Planning has not directed that a public hearing should be held.

Your submission will be published on the NSW Planning Portal in accordance with our privacy statement and disclaimer and declaration. When making a submission you will be required to include:

- your name and address
- the name of the application and the application number
- a statement on whether you 'support' or 'object' to the proposal or if you are simply providing comment
- the reasons why you support or object to the proposal
- a declaration of any reportable political donations you have made in the last two years (visit <u>Donations</u> <u>and Gifts Disclosure</u> or phone 1300 305 695 to find out more)
- an acknowledgement that you accept the department's disclaimer and declaration.
