Thank you for the application provided to undertake works on the Guthega home trail.

A new **Estimated Development Cost** based on Planning Circular PS24-002 is to be provided (new circular since March 2024). As indicated in the Circular, for an EDC up to \$3 Million, the development cost must be calculated by a **suitably qualified person**. This may be a builder who is licensed to undertake the proposed works, a registered architect, a qualified and accredited building designer, a quantity surveyor or a person who is similarly licensed and has the relevant qualifications and proven experience in costing of development works at least to a similar scale and type as is proposed. Ensure the EDC covers all works, breakdowns each component (excavation, retaining, etc) and provides a genuine estimate (whether this is supported by quotes).

The Department recommends the geotech report / Form be updated and include the submitted CLM CiVil drawings. Also check with the geotech, whether this would require an inspection and site investigation now when reviewing the CLM CiVil drawings as the extent of the works / widths appears to be greater when comparing the current geotech report and the CLM CiVil drawings. The discussion and recommendation section of the geotech report should be reviewed.

There might be other components during the assessment, but the above is requested prior to lodgement. Should the geotech require additional investigation, please advise.

I will add this into the Planning Portal as an additional information request.
