Terms Of Consent

- A2. The development may only be carried out:
 - (a) in compliance with the conditions of this consent;
 - (b) in accordance with all written directions of the Planning Secretary;
 - (c) in accordance with the SEE and Response to Submissions;
 - (d) in accordance with the approved plans and reports in the tables below:

- A3. Consistent with the requirements in this consent, the Planning Secretary may make written directions to the Applicant in relation to:
 - (a) the content of any strategy, study, system, plan, program, review, audit, notification, report or correspondence submitted under or otherwise made in relation to this consent, including those that are required to be, and have been, approved by the Planning Secretary; and
 - (b) the implementation of any actions or measures contained in any such document referred to in condition **A2(a)** above.
- A4. The conditions of this consent and directions of the Planning Secretary prevail to the extent of any inconsistency, ambiguity or conflict between them and a document listed in condition **A2(d)**. In the event of an inconsistency, ambiguity or conflict between any of the documents listed in condition **A2(d)**, the most recent document prevails to the extent of the inconsistency, ambiguity or conflict.

Limits Of Consent

- A5. This consent will lapse five years from the date of consent unless the signage works associated with the project have physically commenced.
- A6. This consent does not approve:
 - (a) vegetation or tree removal with the exception of the 13 trees listed for removal in the Arboricultural Impact Assessment listed in condition A2(d). Tree removal works must be in accordance with the Tree Management Plan in the Arboricultural Impact Assessment.
 - (b) works associated with the installation of any electricity or telecommunications cables to service the site.

A modification Separate development application(s) must be lodged, and consent obtained, for the above works (except where consent is not required under an Environmental Planning Instrument or exempt and complying development applies).

Evidence of Consultation

- A7. Where conditions of this consent require consultation with an identified party, the Applicant must:
 - (a) consult with the relevant party prior to submitting the subject document to the Planning Secretary for consent; and
 - (b) provide details of the consultation undertaken including:
 - (i) the outcome of that consultation, matters resolved and unresolved; and
 - (ii) details of any disagreement remaining between the party consulted and the Applicant and how the Applicant has addressed the matters not resolved.

Duration Of Consent

This development consent is issued for a limited period of 15 years. The consent will cease to be in force/expire 15 years after the date of consent.

Note: a new Development Application must be submitted prior to that date for assessment and determination if it is intended to continue the use beyond the cessation date.

Structural Adequacy

All new structures, and any alterations or additions to existing structures, that are part of the development, must be constructed in accordance with the relevant requirements of the BCA. All structural works must be designed and certified by a suitability qualified and practising structuralengineer and a suitability qualified and practising geotechnical engineer.

Note: Under Part 6 of the EP&A Act, Crown building work cannot be commenced unless the Crown building work is certified by or on behalf of the Crown to comply with the Building Code of Australia.

Wind Loading

A10. The approved sign must meet wind loading requirements as specified in Australian Standard AS 1170.1: Structural Design Actions - Permanent, Imposed and Other Actions (as adopted by the BCA) and AS 1170.2:- Structural Design Actions - Wind Actions (as adopted by the BCA).

Reflectivity

A11. The visible light reflectivity from the proposed LED screen and materials used on the signage structure shall not exceed 20 per cent and shall be designed so as to minimise glare.

Operation of Plant and Equipment

- A12. All plant and equipment used on site, or to monitor the performance of the development must be:
 - maintained in a proper and efficient condition; and
 - operated in a proper and efficient manner. (b)

Applicability of Guidelines

- A13. References in the conditions of this consent to any guideline, protocol, Australian Standard or policy are to such guidelines, protocols, Standards or policies in the form they are in as at the date of this consent.
- A14. However, consistent with the conditions of this consent and without altering any limits or criteria in this consent, the Planning Secretary may, when issuing directions under this consent in respect of ongoing monitoring and management obligations, require compliance with an updated or revised version of such a guideline, protocol, Standard or policy, or a replacement of them.

Incident Notification, Reporting and Response

A15. The Department must be notified in writing to compliance@planning.nsw.gov.au immediately after the Applicant becomes aware of an incident. The notification must identify the development (including the development application number and the name of the development if it has one) and set out the location and nature of the incident.

Prescribed Conditions

A16. The Applicant shall comply with all relevant prescribed conditions of development consent under Part4. Division 2 of the EP&A Regulation.

Non-Compliance Notification

- A17. The notification The Department must be notified in writing to compliance@planning.nsw.gov.auwithin seven days after the Applicant becomes aware of any non-compliance. The Certifying Authority must also notify the Department in writing to compliance@planning.nsw.gov.au within seven days after they identify any non-compliance.
- A18. The notification must identify the development and the application number for it, set out the condition of consent that the development is non-compliant with, the way in which it does not comply and the reasons for the non-compliance (if known) and what actions have been, or will be, undertaken to address the non-compliance

A19. A non-compliance which has been notified as an incident does not need to also be notified as a non-compliance.

Development Near Busy Roads

A20. The sign must comply with all requirements of the NSW Department of Planning Development Near Rail Corridors and Busy Roads – Interim Guidelines, December 2008 (DNRCBR 2008).

Design And Operation

A21. The proposed sign design and operation shall be in accordance with the Transport Corridor Outdoor Advertising and Signage Guidelines 2017 requirements.

Advertisements Generally

A22. Advertisements displayed on the LED advertising screen must be in accordance with the guidelines for sign content outlined in Section 3.6 of the Transport Corridor Outdoor Advertising and Signage Guidelines, dated November 2017.

Advertisements - Dwell Time

A23. Static digital advertisements are to be displayed on the digital LED with a minimum dwell time of 25 seconds

Advertisements - Transition Time

A24. The transition time between different static digital advertisements displayed on the digital LED screen must be no longer than 0.1 second.

Permitted Luminance Levels

A25. The luminance levels of the LED advertising screen must comply with Australian Standard AS 4282-2019 Control of the obtrusive effects of outdoor lighting, and the below table:

| Lighting Conditions | Permitted Luminance |

| Full Sun on Face of LED Advertising Screen | Maximum Output cd/m² |
| Day time | 6000 cd/m² |
| Morning and Evening Twilight and Inclement Weather | 500 cd/m ² |

- A26. The average luminance difference between successive images must not exceed 30% to ensure compliance with Australian Standard AS 4282-2019 Control of the Obtrusive Effects of Outdoor Lighting.
- A27. The LED advertising screen must include a light sensor to be capable of automatically adjusting the luminance levels in accordance with Condition A25.

Advertisements - Static Advertisements

A28. Advertisements displayed on the LED advertising screen must be displayed in a completely static manner, without any motion, for the approved dwell time in condition **A23**.

Advertisements - Text

A29. Advertisements displayed on the LED advertising screen must minimise the amount of text and information displayed (for example no more than a driver can read at a short glance). Text shall be displayed in the same font and size (further guidance provided in condition **A31**).

Advertisements - Message Sequencing

A30. Message sequencing designed to make a driver anticipate the next message is prohibited across images presented on a single sign and across a series of signs.

Advertisements - Traffic Control Device Or Driving Instructions

- A31. Advertisements displayed on the LED advertising screen must not be capable of being mistaken:
 - (a) for a prescribed traffic control device because it has, for example, red, amber or green circles, octagons, crosses or triangles or shapes or patterns that may result in the advertisement being mistaken for a prescribed traffic control device; or
 - (b) as text providing driving instructions to drivers.

Advertisements - Interactive Technology

A32. The proposed sign must not incorporate technology that will interact with in-vehicle electronic devices or mobile devices.

Advertisements - Dazzle Or Distract Drivers

A33. Advertisements displayed on the LED advertising screen must not otherwise unreasonably dazzle or distract drivers without limitation to their colouring or contain flickering or flashing content.

Display Of Road Safety And Emergency Messages

A34. The LED advertising screen shall be available for 5 minutes per hour for the display of customer promotion and event messages by arrangement with TfNSW and Sydney Trains at no cost to TfNSW. Additionally, the LED advertising screen shall be made available for use, at no cost, to allow emergency messaging to override the commercial advertising.

Note: the emergency messaging, including station emergency situations, major disruptions to the rail network and Threat-to-life alerts by NSW Government Emergency and Police Agencies, are not included in the 5 minutes per hour

Road Safety Check

- A35. The Applicant must prepare an independent Road Safety Assessment (RSA) after 12 months of operation of the digital signage but within 18 months of the sign's installation. The road safety check must be carried out by an independent TfNSW accredited road safety auditor and in in accordance with the RMS Guidelines for Road Safety Audit Practices. A copy of the report is to be provided to TfNSW and any safety concerns identified by the auditor relating to the operation or installation of the sign must be rectified by the Applicant.
- A36. In the event the findings and/or recommendations of the RSA cannot be addressed by the Applicant, the sign is to be removed at no cost to TfNSW.

Electronic Log

A37. An electronic log of the sign's activities must be maintained by the operator for the duration of the development consent and be available to the consent authority and TfNSW to allow a review of the signs' activity in case of a complaint.

Legal Notices

A38. Any advice or notice to the consent authority shall be served on the Planning Secretary.

National Park Access

A39. The Royal National Park is not to be used to gain access to the development site or for the storage of materials, equipment, workers' vehicles or machinery at any time during construction or operation of the development.

END OF PART A

PART B PRIOR TO COMMENCEMENT OF WORKS

Notification Of Commencement

- The Planning Secretary must be notified in writing of the dates of commencement of physical work and operation at least 48 hours before those dates.
- If the construction or operation of the development is to be staged, the Planning Secretary must be B2. notified in writing at least 48 hours before the commencement of each stage, of the date of commencement and the development to be carried out in that stage.

Compliances

The Applicant must ensure that all of its employees, contractors (and their sub-contractors) are made aware of, and are instructed to comply with, the conditions of this consent relevant to activities they carry out in respect of the development.

Road Occupancy Licence

A Road Occupancy Licence (ROL) should be obtained from Transport Management Centre for any works that may impact on traffic flows during construction activities. A ROL can be obtained through https://myrta.com/oplinc2/pages/security/oplincLogin.jsf

Structural Details

- Prior to the commencement of construction, the Applicant shall submit to the satisfaction of the TfNSW engineers structural drawings prepared and signed by a suitably gualified practising Structural Engineer that comply with:
 - (a) any relevant clauses of the BCA;
 - the development consent; (b)
 - approved drawings and specifications; and (c)
 - approved drawings and specifications as part of the Crown Certification process. (d)
- B6. Prior to the commencement of construction, the Applicant shall submit to the satisfaction of the TfNSW engineers details of the 'fall arrest' system that is intended to prevent the sign structure fall on traffic should it be impacted by high vehicles.

Construction Management Plan

- Prior to the commencement of works, a Construction Management Plan (CMP) shall be prepared and submitted to the Department and Council. The CMP shall address, but not be limited to the following matters where relevant:
 - (a) Environmental and Safety Risk Assessment;
 - noise management in accordance with the Interim Construction Noise Guidelines (Department (b) of Environment and Climate Change, 2009)
 - hours of work (to ensure minimal disruption of any surrounding residential amenity and traffic (c) operation);
 - (d) contact details of site manager;
 - safety, including preparation of a Safe Work Method Statement; (e)
 - traffic management, including details of the location of any site compound, haulage routes and (f) parking for vehicles associated with the construction (i.e. parked vehicles shall not impede the movement of traffic or pedestrians in and around the site);
 - waste management; (g)
 - tree protection measures as per the tree protection plan as required by condition B12 (as (h) required);
 - external lighting in compliance with AS4282: 1997 Control of the Obtrusive Effects of Outdoor (i) Lighting; and
 - flora and fauna management. (j)

The CMP must not include works that have not been explicitly approved in the development consent. In the event of any inconsistency between the consent and the CMP, the consent shall prevail.

Payment Of Levy Fee

B8. Any required payment of the relevant Long Service Levy Fee is to be made prior to the commencement of construction.

Sedimentation

B9. Prior to commencement of work on the site for each stage of the development, erosion and sedimentation control measures are to be installed and operational.

Geotechnical Engineering Report

B10. Prior to the commencement of works, a Geotechnical Engineering Report, prepared by a suitability qualified person, must be submitted to the Certifying Authority for approval detailing any special building practices required for construction of the proposed development. A copy of the approved Geotechnical Engineering Report must be submitted to the Department for information.

Shoring

B11. Prior to the commencement of works, detailed plans of the shoring for the footing installation must be submitted to the Certifying Authority for approval. The plans must be prepared by a suitably qualified practicing structural engineer to ensure no adverse impacts to the rail track underpass culvert wall.

Tree Protection

B12. Prior to the commencement of any works, a Tree Protection Plan prepared in accordance with *Australian Standard AS 4970-2009 'Protection of Trees on Development Sites'* must be submitted and approved by the Certifying Authority.

The Plan must:

- (a) be prepared by a qualified Arborist;
- (b) identify all trees surrounding the location of construction activities;
- (c) detail protection measures for trees identified in condition B12(b), with the exception of those identified for removal in the Arboricultural Impact Assessment listed in condition A2(d), to ensure they are retainedduring construction and operation of the development;
- (d) show the Tree Protection Zones for retained vegetation, amelioration measures if works are to be undertaken within the tree protection zone; and
- (e) identify any stockpiling areas.

Tree protection works must be consistent with the Method Statement in the Arboricultural Impact Assessment listed in condition A2(d).

PART C DURING CONSTRUCTION

Approved Plans To Be On-Site

C1. A copy of the approved and certified plans, specifications and documents incorporating conditions of consent and certification shall be kept on the subject site at all times and shall be readily available for perusal by any officer of the Department or Council.

Site Notice

C2.

- (a) A site notice(s) shall be prominently displayed at the boundaries of the subject site for the purposes of informing the public of project details including, but not limited to the details of the Builder, Structural Engineer and contact details, including contact phone number.
- (b) The notice(s) is to satisfy all but not be limited to, the following requirements:
 - (i) minimum dimensions of the notice are to measure 841mm x 594mm (A 1) with any text on the notice to be a minimum of 30 point type size;
 - (ii) the notice is to be durable and weatherproof and is to be displayed throughout the works period;
 - (iii) the approved hours of work, the name of the site/project manager, the responsible managing company (if any), its address and 24 hour contact phone number for any inquiries, including construction/noise complaint are to be displayed on the site notice; and
 - (iv) the notice(s) is to be mounted at eye level on the perimeter hoardings/fencing and is to state that unauthorised entry to the subject site is not permitted.

Construction Hours

- C3. Construction, including the delivery of materials to and from the site, may only be carried out between the following hours:
 - (a) between 7:00 am and 6:00 pm, Mondays to Fridays inclusive
 - (b) between 8:00 am and 1:00 pm, Saturdays.
- C4. No work may be carried out on Sundays or public holidays.
- C5. Works may be undertaken outside these hours where:
 - (a) the delivery of materials or works is required outside these hours by the Police, TfNSW or other authorities:
 - (b) it is required in an emergency to avoid the loss of life, damage to property and/or to prevent environmental harm; or
 - (c) it is required in accordance with a Road Occupancy Licence or at the direction of the Transport Management Centre (TMC).
- C6. Notification of such activities must be given to affected residents before undertaking the activities or as soon as is practical afterwards.

Implementation Of Management Plan

C7. The Applicant must carry out the construction of the development in accordance with CMP required by condition **B7**.

Construction Noise Management

- C8. The development shall be constructed with the aim of achieving the construction noise management levels detailed in the Interim Construction Noise Guideline (Department of Environment and Climate Change, 2009).
- C9. Any noise generated during the construction of the development must not be offensive noise within the meaning of *the Protection of the Environment Operations Act*, 1997.

Construction Dust Management

- C10. The Applicant must take all reasonable steps to minimise dust generated during all works authorised by this consent.
- C11. During construction, the Applicant must ensure that:
 - (a) activities are carried out in a manner that minimises dust including emission of windblown or traffic generated dust;
 - (b) all trucks entering or leaving the site with loads have their loads covered;
 - (c) trucks associated with the development do not track dirt onto the public road network;
 - (d) public roads used by these trucks are kept clean; and
 - (e) land stabilisation works are carried out progressively on site to minimise exposed surfaces

Safe Work NSW Requirements

C12. To protect the safety of work personnel and the public, the work site shall be adequately secured to prevent access by unauthorised personnel, and work shall be conducted at all times in accordance with relevant Safe Work NSW requirements.

Hoarding Requirements

- C13. The following hoarding requirements shall be complied with:
 - (a) no third party advertising is permitted to be displayed on the subject hoarding/fencing; and
 - (b) the construction site manager shall be responsible for the removal of all graffiti from any construction hoardings or the like within the construction area within 48 hours of its application.

No Obstruction Of Public Way

C14. The public way (outside of any construction works zone) must not be obstructed by any materials, vehicles, refuse, skips or the like, under any circumstances. Non-compliance with this requirement will result in the issue of a notice by the relevant Authority to stop all work on site.

TfNSW Supervision

C15. The installation of the signage shall be in accordance with TfNSW requirements. Installation of signage should be completed by a TfNSW registered consultant. Any works on a TfNSW asset should be supervised by an authorised TfNSW contractor.

Excavation

C16 Where excavation works are to take place on the site, erosion and sediment control measures are to be implemented in accordance with *Managing Urban Stormwater: Soils and Construction 4th Edition - Vol. 1* (the "Blue Book") published by Landcom, 2004.

Vibration Criteria

- C17. Vibration caused by construction at any residence or structure outside the site must be limited to:
 - (a) for structural damage, the latest version of DIN 4150-3 (1992-02) Structural vibration Effects of vibration on structures (German Institute for Standardisation, 1999); and
 - (b) for human exposure, the acceptable vibration values set out in the Environmental Noise Management Assessing Vibration: a technical guideline (DEC, 2006) (as may be updated or replaced from time to time)

Tree Protection

- C18. Protective fencing shall be installed prior to commencement of any works in accordance with the Tree Protection Plan approved under condition **B12**.
- C19. The storage of any debris, materials or machinery is not to occur within the drip line of any protected vegetation.

Unexpected Finds Protocol – Aboriginal Heritage

- C20. In the event that surface disturbance identifies a new Aboriginal object:
 - (a) all works must halt in the immediate area to prevent any further impacts to the object(s);
 - (b) a suitably qualified archaeologist and the registered Aboriginal representatives must be contacted to determine the significance of the objects;
 - (c) the site is to be registered in the Aboriginal Heritage Information Management System (AHIMS) which is managed by Heritage NSW under Department of Premier and Cabinet and the management outcome for the site included in the information provided to AHIMS;
 - (d) the Applicant must consult with the Aboriginal community representatives, the archaeologists and Heritage NSW to develop and implement management strategies for all objects/sites; and
 - (e) works may only recommence with the written approval of the Planning Secretary.

Unexpected Finds Protocol – Historic Heritage

- C21. If any unexpected archaeological relics are uncovered during the work, then:
 - (a) all works must cease immediately in that area and notice is to be given to Heritage NSW and the Planning Secretary;
 - (b) depending on the possible significance of the relics, an archaeological assessment and management strategy may be required before further works can continue in that area as determined in consultation with Heritage NSW; and
 - (c) works may only recommence with the written approval of the Planning Secretary.

Tree Protection During Construction

- C22. During construction, tree protection measures must be maintained in accordance with the relevant provisions of:
 - (a) AS-4970: Protection of trees on development sites
 - (b) Chapter 39 of Sutherland Shire Development Control Plan 2015; and
 - (c) the Arboricultural Impact Assessment listed in condition A2(d).

Tree Replacement

- C23. Where trees are removed, replacement trees must:
 - (a) be provided at a ratio of at least 2:1;
 - (b) be endemic species and selected from Sutherland Shire Council's 'Native Plant Selector' available on council's website;
 - (c) meet the requirements for quality tree stock specified in the AS2303:2018: Tree Stock for Landscape Use;
 - (d) be of a minimum pot size of 100 litres;
 - (e) be located within 100 metres of the signage structure and where possible, positioned to provide screening of the sign from nearby residents; and
 - (f) be planted prior to commencement of operation.

Revegetation Management Plan

- C24. A Revegetation Management Plan must be prepared by a suitably qualified and experienced person in native revegetation. The Plan must be prepared and submitted to the Department prior to commencement of operation of the sign. The Plan must address, but not be limited to:
 - (a) details on the species to be planted on-site, ensuring that at least 80% of new understorey plants are endemic species selected from Sutherland Shire Council's 'Native Plant Selector':
 - (b) a description of the routine monitoring and maintenance measures to manage the planted vegetation to ensure the success of the revegetation outcomes;

- (c) weed management, including measures to ensure regeneration of weeds does not occur and imported fill, topsoil or landscaping material is free of weeds; and
- (d) measures for stabilising the cleared area and preventing soil erosion in the revegetated area.

The Revegetation Management Plan must be implemented.

Nest Boxes

C25. Existing nest boxes must be removed prior to tree felling. The nest boxes must be relocated within one week of removal and within 50 metres of the felled trees. Removal and relocation must be in the presence of an ecologist.

Works Near Power Lines

- C26. All works adjacent to the overhead power lines must be undertaken in accordance with Work Near Overhead Power Lines: Code of Practice (WorkCover, 2006).
- C27. Replacement trees must be planted at a distance so that when full size, they are outside the minimum clearance distance from the power lines, as outlined in NS220 Overhead Design Manual (Ausgrid, 2020 as amended on 26/06/2024).

PART D PRIOR TO COMMENCEMENT OF USE

Notification of Commencement of Use

D1. At least one month before commencement of operation, the date of commencement of the operation or use of the development must be notified to the Planning Secretary in writing. If the operation of the development is to be staged, the Planning Secretary must be notified in writing at least one month before the commencement of each stage, of the date of commencement and the development to be carried out in that stage.

Protection Of Public Infrastructure

- D2. Unless the Applicant and the applicable authority agree otherwise, the Applicant must:
 - (a) repair, or pay the full costs associated with repairing, any public infrastructure that is damaged by carrying out the development; and
 - (b) relocate, or pay the full costs associated with relocating any infrastructure that needs to be relocated as a result of the development.

Maintenance Plan

- D3. Prior to the commencement of use, a Maintenance Plan is to be prepared and submitted to the Department and Council. The Plan shall address, but not be limited to, the following matters, where relevant.
 - (a) Environmental and Safety Risk Assessment;
 - (b) hours of work/inspections of sign (to ensure minimal disruption of any surrounding residential amenity and traffic operation);
 - (c) contact details of site manager;
 - (d) safety, including preparation of a Safe Work Method Statement;
 - (e) traffic management, including details of the location of parking for vehicles associated with the operation (i.e. parked vehicles shall not impede the movement of traffic or pedestrians in and around the site);
 - (f) external lighting in compliance with AS4282: 1997 Control of the Obtrusive Effects of Outdoor Lighting; and
 - (g) removal of graffiti.; and
 - (h) maintenance and management of vegetation.

Road Damage

D4. The cost of repairing any damage caused to Council or other Public Authority's assets in the vicinity of the subject site as a result of construction works associated with the approved development, is to be met in full by the Applicant.

Structural Inspection Certificate

- D5. A Structural Inspection Certificate or a Compliance Certificate must be submitted to the satisfaction of the Certifying Authority prior to commencement of use. A copy of the Certificate with an electronic set of final drawings (contact consent authority for specific electronic format) shall be submitted to the Department and the Council after:
 - (a) the site has been periodically inspected and the Certifying Authority is satisfied that the structural works is deemed to comply with the final design drawings; and
 - (b) the drawings listed on the Inspection Certificate have been checked with those listed on the final Design Certificate/s.

PART E ONGOING CONDITIONS

Maintenance

- E1. Regular maintenance of the approved advertising structures shall be undertaken in accordance with the Maintenance Plan under condition **D3**. The sign is to be inspected regularly to identify any damage from storms, graffiti or the like.
- E2. All costs associated with the proposed sign, including maintenance activities, shall be at no cost to TfNSW.

Advertising Signage Content

- E3. The approved advertising structures must not have or use:
 - (a) flashing or flickering lights or content
 - (b) electronically changeable messages
 - (c) animated display, moving parts or simulated movement
 - (d) complex displays that hold a driver's attention beyond "glance appreciation"
 - (e) displays resembling traffic signs or signals, or giving instructions to traffic by using colours and shapes that imitate a prescribed traffic control device or words such as 'halt' or 'stop'
 - (f) a method of illumination that distracts or dazzles
 - (g) floodlighting or the like
 - (h) dominant use of colours red or green
 - (i) technology that interacts with vehicle-electronic devices or mobile devices.

Signage content must also comply with all conditions contained in Part A of this consent and be in accordance with the road safety guidelines for sign content, set out in Guidelines.

Wiring

E4. Any wiring to approved signage must be contained behind the sign or otherwise concealed so that wiring is not visible from a public place.

Location Of Certain Names And Logos

E5. The name or logo of the person who owns or leases the approved advertisement may appear only in the logo space attached to the bottom centre of the advertising structure as shown in the plans listed in condition **A2** and must be no greater than 0.25 m² in size.

Removal Of Graffiti

E6. The owner/manager of the site or sign must be responsible for the removal of all graffiti from the advertising structure within 48 hours of notification.

Advertising Revenue/Public Benefit

E7. The total amount of outdoor advertising revenue received each year by Sydney Trains must be recorded in its financial accounts and Annual Reports. The Annual Reports must also outline how revenue has been applied to provide a public benefit in the areas of transport safety, amenity improvements or other public works, listing specific works to which the funds have been or are to be applied.

Revegetation Management

E8. Ongoing management of revegetation works must be undertaken in accordance with the Revegetation Management Plan under condition C24.

Appeals

AN1. The Applicant has the right to appeal to the Land and Environment Court in the manner set out in the Environmental Planning and Assessment Act 1979 and the Environmental Planning and Assessment Regulation 2021 (as amended).

Other Consents And Permits

AN2. The Applicant shall apply to the Council for all necessary permits including crane permits, road opening permits, hoarding or scaffolding permits, footpath occupation permits and/or any other consents under Section 68 (Consents) of the *Local Government Act 1993* or Section 138 of the *Roads Act 1993*.

Responsibility For Other Consents And Agreements

AN3. The Applicant is solely responsible for ensuring that all additional consents and agreements are obtained from other authorities, as relevant.

Movement Of Trucks Transporting Material

AN4. The Applicant must notify the TfNSW Traffic Management Centre (TMC) of the truck route(s) to be followed by trucks transporting material from the subject site, prior to the commencement of works.

Disability Discrimination Act

AN5. This application has been assessed in accordance with the Environmental Planning and Assessment Act 1979. No guarantee is given that the proposal complies with the Disability Discrimination Act 1992. The Applicant/owner is responsible to ensure compliance with this and other anti-discrimination legislation. The Disability Discrimination Act 1992 covers disabilities not catered for in the minimum standards called up in the Building Code of Australia which references AS 1428.1 - Design for Access and Mobility. AS1428 Parts 2, 3 & 4 provides the most comprehensive technical guidance under the Disability Discrimination Act 1992 currently available in Australia.
