Description of proposal

The proposal seeks consent to amend Development Consent no. DA9876 (as modified) to allow for a partially revised subdivision layout. The amending subdivision scheme involves:

- consolidation of 32 approved lots to create 10 larger lots
- associated subdivision works, including changes to internal road layout, drainage and landscaping,
 and
- changes to approved construction staging.

About the exhibition

An exhibition process allows any individual or organisation to have their say about a proposed development.

The Department of Planning, Housing and Infrastructure (the department) has received a development application for the abovementioned proposal. - indicate whether you 'support' or 'object' to the proposal or if you are simply providing comment
- the reasons why you support or object to the proposal
- a declaration of any reportable political donations you have made in the last two years (visit <u>www.planning.nsw.gov.au/Assess-and-Regulate/Development-Assessment/Planning-Approval-Pathways/Donations-and-Gift-Disclosure or phone 1300 305 695 to find out more)</u>
- an acknowledgement that you accept the department's disclaimer and declaration.
