### **RE-USE/RECYCLING/DISPOSAL**

#### Waste Requirements for a proposal

General waste: 2 x 120 Litre Bins Recyclable

Materials: 2 X 240 Litre Bins Green Waste

Owners to manage waste on a daily basis - separating materials into re-useables, recyclables,

waste and garden organics for inclusion in appropriate disposal bin.

Provision for waste bins is made for each dwelling as follows:

- bins are to be placed to the side yard ;
- Bins to be placed at kerbside in front of dwelling on specified days for collection by Council
