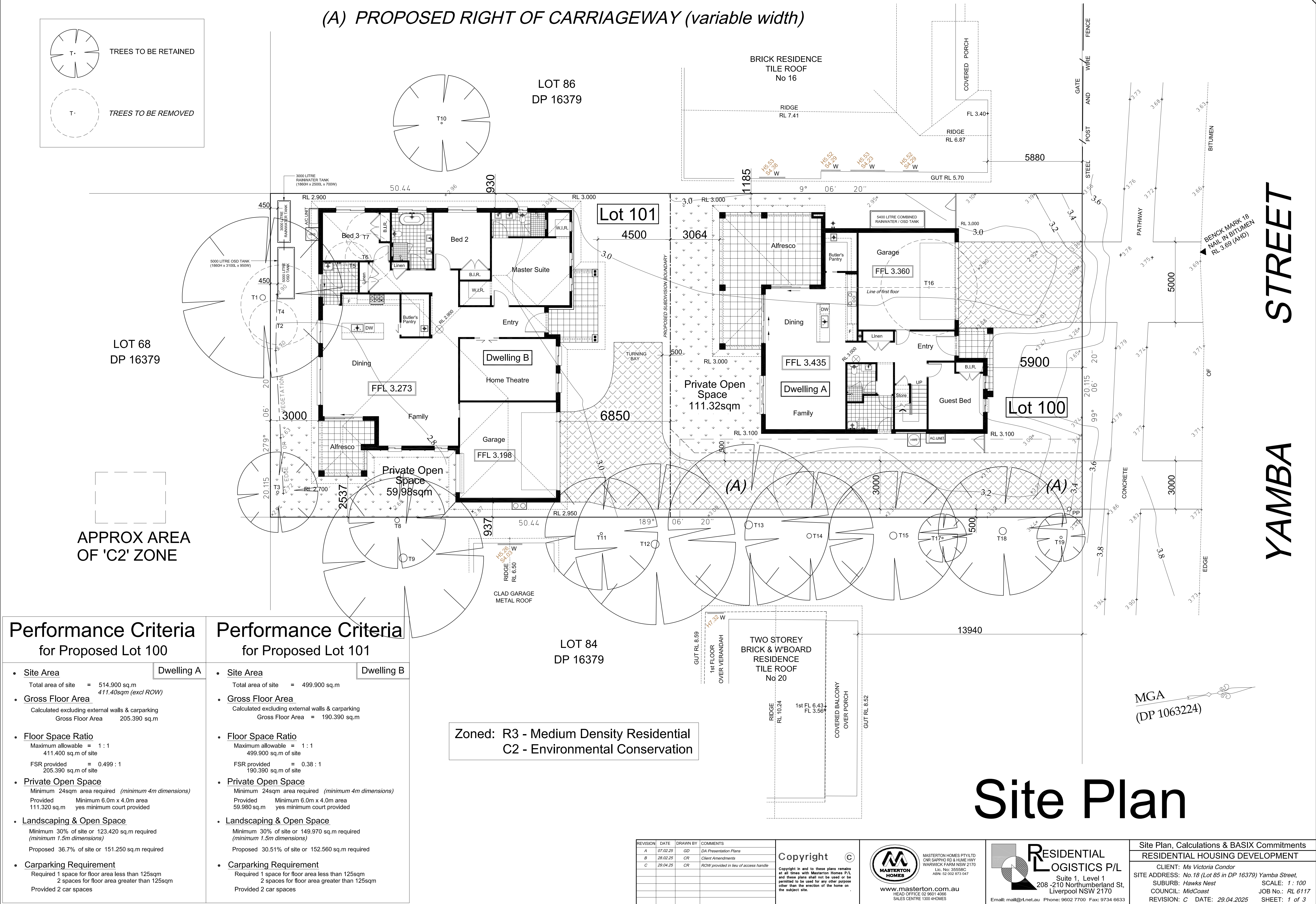
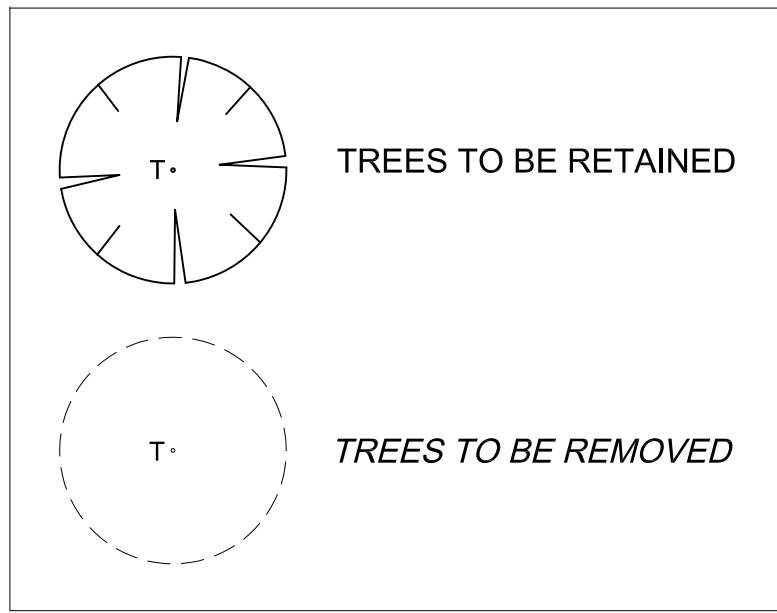


(A) PROPOSED RIGHT OF CARRIAGEWAY (variable width)
