Following in blue are the quoted rates for 2025 season for Selwyn Ski Resort.

- 14000 litre & 12000 litre Rigid Truck - Rate is per litre for Transport, Loading, Unloading and Disposal in Canberra
For Weekday travel Monday to Friday Day Shifts = [REDACTED]
- 14000 litre & 12000 litre Rigid Truck - Rate is per litre for Transport, Loading, Unloading and Disposal in Canberra
For Weekends, Public Holidays or Night Shifts = [REDACTED]

Notes:

1. Escort onsite is to be supplied by client.
2. Maximum of 5 hours return trip Cooma to Cooma has been allowed for. Delays onsite or out of the control of SDS may incur additional hourly charges.
3. Capacity and frequency of service to be confirmed.
4. SDS allocated 2 x Semi Trailers, and 2 x Rigid Trucks where required for the duration of the season.
5. If escort vehicle required for Snowy Mountains Highway during weather events, this can be supplied at [REDACTED] **weekdays during normal business hours** and [REDACTED] **outside of these hours**.

Based on capacity we have arranged the disposal point with Icon Water in Canberra, however we have been advised that in the case of a severe weather event there could be issues with disposal, and this would be beyond the controls of SDS. This would require short term storage solutions in Cooma if required at additional cost.

I have reached out to Cooma Council relating to testing and disposal, however, have not received an answer from them regarding costings and availability for disposal for the 2025 season in Cooma.
If Cooma is available as a disposal point, we will charge this when invoiced to SDS at invoice cost plus 10%

Following, are transport loading and unloading costs for permeate water at Cooma.
