Description of proposal

Building alterations and additions to two food and beverage outlets – Alpine Pizzeria and Izakaya that are part of the Thredbo Alpine Hotel. The application is seeking consent for the following: 1. Authorise "use" of existing food and beverage outlet; 2. Building alterations and additions; 3. Amend the Pizzeria liquor licence and add Izakaya premises to both be part of the Hotel General Licence.

About the exhibition

the abovementioned proposal.

Have your say

If you think you'll need help making a submission using the portal, it's a good idea to contact Service NSW sooner rather than later. Ensure you give yourself plenty of time to make a submission before the project's exhibition end date.

Your submission will be published on the NSW Planning Portal in accordance with our privacy statement and disclaimer and declaration. You can elect to have your name withheld from the published list of submitters. When making a submission you will be required to include:

- your name and address
- the name of the application and the application number
- a statement on whether you 'support' or 'object' to the proposal or if you are simply providing comment
- the reasons why you support or object to the proposal
- a declaration of any reportable political donations you have made in the last two years (visit <u>Donations and Gift Disclosure</u> or phone 1300 305 695 to find out more)
- an acknowledgement that you accept the department's disclaimer and declaration.
