Description of proposal

Removal of two existing illuminated advertising signs and installation of one new digital advertising sign at the southern elevation of the railway overpass bridge elevated above George Street.

The application is nominated integrated development requiring general terms of approval from Heritage NSW under Section 57 of the *Heritage Act 1977*, due to the erection of the sign on a State heritage listed item.

About the exhibition

The Department of Planning, Housing and Infrastructure (the department) has received a development application for the abovementioned proposal.
